

#### MR. PRESIDENT:

The Committees on Health and Demography, and Finance, to which was referred **House Bill No. 6972**, introduced by Representatives Y.M.K. Romualdez and F.M.G. Romualdez, entitled:

#### AN ACT

RENAMING THE EASTERN VISAYAS REGIONAL MEDICAL CENTER IN THE CITY OF TACLOBAN, PROVINCE OF LEYTE INTO EASTERN VISAYAS MEDICAL CENTER, INCREASING ITS BED CAPACITY FROM FIVE HUNDRED (500) TO ONE THOUSAND FIVE HUNDRED (1,500) BEDS, AND APPROPRIATING FUNDS THEREFOR

and taking into consideration **Senate Bill No. 1378**, introduced by Senator Marcos, entitled:

#### **AN ACT**

RENAMING THE EASTERN VISAYAS REGIONAL MEDICAL CENTER IN TACLOBAN CITY AND INCREASING THE BED CAPACITY THEREOF FROM FIVE HUNDRED (500) TO ONE THOUSAND FIVE HUNDRED (1,500), AUTHORIZING THE INCREASE OF ITS MEDICAL PERSONNEL, UPGRADING ITS SERVICES, FACILITIES AND PROFESSIONAL HEALTH CARE SERVICES AND APPROPRIATING FUNDS THEREFOR

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 6972, taking into consideration Senate Bill No. 1378, be approved with the following amendments:

- 1. On page 1, line 5, between the words "capacity" and "shall", insert the phrase "AND SERVICE CAPABILITY".
- 2. On page 1, line 22, insert two new Sections, which shall read as follows:

  "SEC. 6. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED

  UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS

  NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

  "SEC. 7. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND

  REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY

  REPEALED OR MODIFIED ACCORDINGLY."
- 3. Renumber the succeeding section accordingly.

(In substitution of House Bill Number 1154)

#### AN ACT

RENAMING THE EASTERN VISAYAS REGIONAL MEDICAL CENTER IN THE CITY OF TACLOBAN, PROVINCE OF LEYTE INTO EASTERN VISAYAS MEDICAL CENTER, INCREASING ITS BED CAPACITY FROM FIVE HUNDRED (500) TO ONE THOUSAND FIVE HUNDRED (1,500) BEDS, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The Eastern Visayas Regional Medical Center in the City of Tacloban, Province of Leyte, is hereby renamed Eastern Visayas Medical Center (EVMC).
- SEC. 2. The bed capacity of the EVMC shall be increased from five hundred (500) to one thousand five hundred (1,500) beds. Any future increase in bed capacity shall be consistent with the hospital development plan which shall be prepared by the Department of Health (DOH).
- SEC. 3. The existing professional health care services and facilities of the EVMC are also upgraded to conform with and be commensurate to the increase in bed capacity as provided for in Section 2 hereof.
- SEC. 4. The existing workforce of the EVMC, which includes doctors, nurses, and support personnel, shall also be increased correspondingly. The Secretary of the DOH shall, after consultation with the Chief of the EVMC, and in coordination with the Secretary of the Department of Budget and Management and the Commissioner of the Civil Service Commission, determine the additional new positions to be created and filled up.
- SEC. 5. The Secretary of the DOH shall immediately include in the Department's program the implementation of this Act, the funding of which shall be included in the annual General Appropriations Act.
- SEC. 6. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
