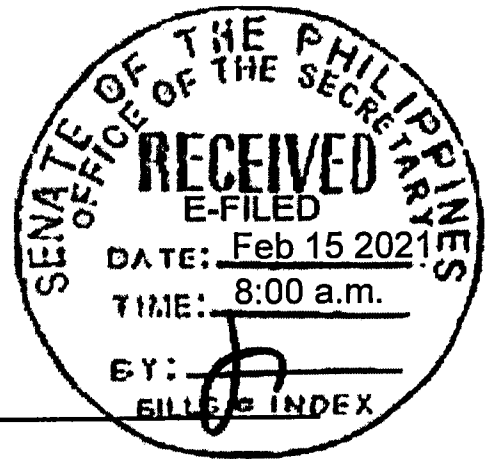

Mr. President:

The Committees on Health and Demography, and Finance, to which was referred **House Bill No. 6753**, introduced by Representative Unabia, entitled:

**AN ACT
CONVERTING THE MEDINA EXTENSION HOSPITAL IN THE MUNICIPALITY OF MEDINA, PROVINCE OF MISAMIS ORIENTAL INTO A GENERAL HOSPITAL TO BE KNOWN AS THE FIRST MISAMIS ORIENTAL GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR**

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 6753 be approved with the following amendments:

1. On page 1, line 9, between the words "capacity" and "and", insert the following: the punctuation mark comma (,) the phrase "**EXPANSION OF SERVICE CAPABILITY**", and the punctuation mark comma (,).

2. On page 2, line 2, between the words "program," and "operation", insert the definite article "**THE**".

3. On the same page, line 11, insert two new Sections, which shall read as follows:

"SEC. 4. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR

PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

"SEC. 5. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."

4. Renumber the succeeding section accordingly.

**AN ACT CONVERTING THE MEDINA EXTENSION HOSPITAL
IN THE MUNICIPALITY OF MEDINA, PROVINCE OF
MISAMIS ORIENTAL INTO A GENERAL HOSPITAL TO
BE KNOWN AS THE FIRST MISAMIS ORIENTAL
GENERAL HOSPITAL, AND APPROPRIATING FUNDS
THEREFOR**

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 **SECTION 1.** The Medina Extension Hospital in the
2 Municipality of Medina, Province of Misamis Oriental is hereby
3 converted into a general hospital to be known as the First Misamis
4 Oriental General Hospital which shall be under the direct control
5 and supervision of the Department of Health (DOH). Henceforth,
6 the First Misamis Oriental General Hospital shall cease to be an
7 extension hospital of the Northern Mindanao Medical Center,
8 Cagayan de Oro City.

9 Any future increase in bed capacity and upgrading of health
10 care services and facilities shall be based on the hospital
11 development plan which shall be prepared by the DOH.

1 **SEC. 2.** The Secretary of Health shall immediately include in
2 the Department's program, operation and maintenance of the First
3 Misamis Oriental General Hospital, the initial funding of which
4 shall be charged against the current year's appropriations of the
5 Medina Extension Hospital. Thereafter, such sums as may be
6 necessary for its continued operation shall be included in the annual
7 General Appropriations Act.

8 **SEC. 3.** The Secretary of Health shall prepare and issue the
9 necessary rules and regulations for the effective implementation of
10 this Act consistent with the hospital development plan.

11 **SEC. 4.** This Act shall take effect fifteen (15) days after its
12 publication in the *Official Gazette* or in a newspaper of
13 general circulation.
