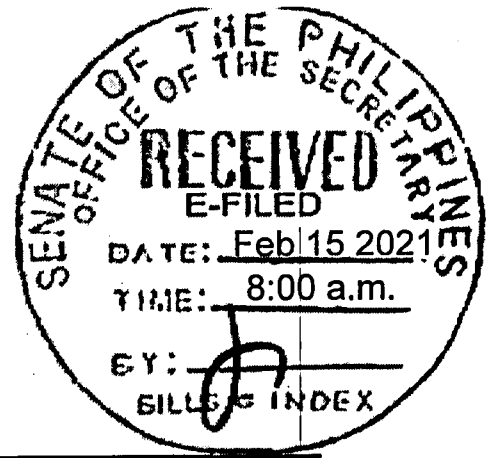

Recommending the approval of House Bill No. 6729 with amendments, taking into consideration Senate Bill No. 1769.

The Committees on Health and Demography, and Finance, to which was referred **House Bill No. 6729**, introduced by Representatives Eriguel and E. Suansing, entitled:

**AN ACT
INCREASING THE BED CAPACITY OF THE ROSARIO DISTRICT
HOSPITAL IN THE MUNICIPALITY OF ROSARIO, PROVINCE OF LA
UNION FROM TWENTY-FIVE (25) TO FIFTY (50) BEDS AND
APPROPRIATING FUNDS THEREFOR**

and taking into consideration **Senate Bill No. 1769**, introduced by Senator Marcos, entitled:

**AN ACT
INCREASING THE BED CAPACITY OF THE ROSARIO DISTRICT
HOSPITAL IN THE MUNICIPALITY OF ROSARIO, PROVINCE OF LA
UNION FROM TWENTY-FIVE (25) TO FIFTY (50) BEDS AND
APPROPRIATING FUNDS THEREFOR**

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 6729, taking into consideration Senate Bill No. 1769, be approved with the following amendments:

1. On page 1, line 4, between the words "capacity" and "shall", insert the phrase **"AND EXPANSION OF SERVICE CAPABILITY."**

2. On page 2, line 7, insert two new Sections, which shall read as follows:

"SEC. 6. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

"SEC. 7. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."

3. Renumber the succeeding section accordingly.

**AN ACT INCREASING THE BED CAPACITY OF THE
ROSARIO DISTRICT HOSPITAL IN THE MUNICIPALITY
OF ROSARIO, PROVINCE OF LA UNION FROM
TWENTY-FIVE (25) TO FIFTY (50) BEDS AND
APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** The authorized bed capacity of the Rosario
2 District Hospital (RDH) in the Municipality of Rosario, Province of
3 La Union is hereby increased from twenty-five (25) to fifty (50) beds.
4 Any future increase in bed capacity shall be consistent with the
5 hospital development plan.

6 **SEC. 2.** The existing professional health care services and
7 facilities are also hereby upgraded to conform with and be
8 commensurate to the bed capacity increase as provided in Section 1
9 hereof.

10 **SEC. 3.** The existing workforce of the RDH, which includes
11 doctors, nurses and support personnel, shall also be increased
12 correspondingly.

1 **SEC. 4.** The Provincial Government of La Union shall provide
2 the necessary funds to support the increase in bed capacity of the
3 RDH and the corresponding upgrading of its facilities and services.

4 **SEC. 5.** The Secretary of Health shall include in the
5 Department of Health's subsidy program its support for the capital
6 outlays of the hospital.

7 **SEC. 6.** This Act shall take effect fifteen (15) days after
8 its publication in the *Official Gazette* or in a newspaper of general
9 circulation.
