

### AN ACT

## AMENDING REPUBLIC ACT NO. 8506 ENTITLED "AN ACT BANNING THE REGISTRATION AND OPERATION OF VEHICLES WITH RIGHT-HAND STEERING WHEEL IN ANY PRIVATE OR PUBLIC STREET, ROAD OR HIGHWAY, PROVIDING PENALTIES THEREFOR AND FOR OTHER PURPOSES"

### EXPLANATORY NOTE


The Philippines is a signatory to the 2009 Memorandum of Understanding (MOU) between Brunei Darussalam, Indonesia, Malaysia and the Philippines (BIMP) on Transit and Inter-State Transport of Goods. This MOU provides for various mechanisms and interventions for the promotion, development, and enhancement of trade and investment among the BIMP – East ASEAN Growth Area (BIMP-EAGA) through the facilitation of inter-state transport of goods and goods in transit among the participating States. Specifically, Section 4.2.2 of this MOU declares that the operation of right and left hand-drive road vehicles be allowed, provided that special permit for such operation is obtained from the relevant Transit and Host Countries.

However, the current law, Republic Act No. 8506, provides that vehicles with right-hand steering wheel cannot be registered and operated in any private or public street, road or highway. Complete ban against the same is contrary to the free movement of goods and connectivity of the country's RO-RO connectivity with ASEAN countries. In view thereof, this bill seeks to amend the current law by allowing temporary admission of right hand-drive private road vehicles from ASEAN countries

provided that a separate special motor vehicle operation permit for the vehicle and special license for the driver are issued by the Department of Transportation.

In view of the foregoing, early passage of this bill is earnestly requested

### AN ACT AMENDING REPUBLIC ACT NO. 8506 ENTITLED "AN ACT BANNING THE REGISTRATION AND OPERATION OF VEHICLES WITH RIGHT-HAND STEERING WHEEL IN ANY PRIVATE OR PUBLIC STREET, ROAD OR HIGHWAY, PROVIDING PENALTIES THEREFOR AND FOR OTHER PURPOSES"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- SECTION 1. A new Section 2 of Republic Act No. 8506 is hereby inserted to

"SECTION 2. ASSOCIATION OF SOUTHEAST ASIAN NATIONS 4 (ASEAN) - REGISTERED PRIVATE RIGHT HAND-DRIVE MOTOR 5 INCLUDING TWO, THREE OR FOUR-WHEEL VEHICLES, 6 MOTORCYCLES, OR MOTORCYCLES WITH SIDE CARS; TOURIST 7 VANS OR BUSES CARRYING TOURISTS FROM ANOTHER 8 COUNTRY; AND DELIVERY TRUCKS OR LORRIES CARRYING g GOODS FROM ANY ASEAN COUNTRY, MAY BE ALLOWED ENTRY 10 AND OPERATION IN ANY HIGHWAY, STREET OR ROAD, 11 WHETHER PRIVATE OR PUBLIC OR OF THE NATIONAL OR LOCAL 12 GOVERNMENT: PROVIDED, THAT A SEPARATE SPECIAL MOTOR 13 VEHICLE OPERATION PERMIT FOR THE VEHICLE AND SPECIAL 14 LICENSE FOR THE DRIVER ARE ISSUED BY THE DEPARTMENT OF 15

TRANSPORTATION (DOTR), OR ANY PUBLIC OFFICE WITH DOTR - DELEGATED AUTHORITY, EACH IN FAVOR OF THE MOTOR 2 VEHICLE AND THE DESIGNATED DRIVER AT THE PORT OF ENTRY FOR A LIMITED DURATION AND SUBJECT TO CONDITIONS AS 4 SET FORTH BY THIS ACT."

SECTION 2. A new Section 3 of Republic Act No. 8506 is hereby inserted to 7 read as follows: 8

**"SECTION 3. AS A CONDITION FOR THE ISSUANCE OF A SPECIAL** 10 PERMIT AND LICENSE TO OPERATE RIGHT HAND-DRIVE MOTOR 11 JURISDICTION, THE PHILIPPINE VEHICLES WITHIN 12 DESIGNATED DRIVER SHALL PRESENT THE VEHICLE'S 13 CURRENT-YEAR ASEAN MOTOR VEHICLE REGISTRATION AND 14 HIS OR HER DRIVER'S LICENSE ISSUED BY THE COUNTRY THAT 15 ISSUED HIS PASSPORT AT THE PORT OF ENTRY. SUCH 16 **REGISTRATION AND LICENSE MUST BE VALID WITHIN THE** 17 DURATION OF THE PERMIT AND LICENSE THAT MAY BE ISSUED 18 IN HIS OR HER FAVOR AND COMPLIANT WITH PHILIPPINE 19 LAND TRANSPORTATION LAWS, RULES AND REGULATIONS: 20 PROVIDED, THAT THE ASEAN COUNTRY OF REGISTRATION OF 21 THE MOTOR VEHICLE EXTENDS RECIPROCAL RIGHTS TO 22 VEHICLES: MOTOR PROVIDED PHILIPPINE-REGISTERED 23 FINALLY, THAT THE DESIGNATED DRIVER IS A NATIONAL OF A 24 COUNTRY THAT ACCORDS RECIPROCAL RIGHTS TO NATIONALS 25 **OF THE PHILIPPINES."** 26

**"SECTION 4. THE SPECIAL MOTOR VEHICLE OPERATION PERMIT** 30 AND SPECIAL DRIVER'S LICENSE TO BE ISSUED SHALL HAVE A 31 VALIDITY OF NOT MORE THAN THIRTY (30) DAYS FROM THE 32

DATE OF ENTRY IF THE PURPOSE IS TO FERRY TOURISTS, AND 1 NOT MORE THAN SEVEN (7) DAYS FROM THE DATE OF ENTRY IF 2 THE PURPOSE IS TO DELIVER GOODS: PROVIDED, THAT NO 3 DELIVERY TRUCKS OR LORRIES CARRYING PASSENGERS SHALL 4 BE ALLOWED ENTRY OR OPERATION: PROVIDED FURTHER, 5 THAT THE ENTRY OF TOURIST VANS OR BUSES CARRYING 6 GOODS ONLY SHALL BE TREATED AS ENTRY FOR DELIVERY OF 7 GOODS: PROVIDED FINALLY, THAT THE COMMERCIAL 8 TRANSPORT OF GOODS OR PASSENGERS ORIGINATING FROM 9 ONE POINT AND ENDING IN ANOTHER POINT AND USING THE 10 SPECIAL MOTOR VEHICLE OPERATION PERMIT AND SPECIAL 11 DRIVER'S LICENSE ISSUED UNDER THIS ACT, BOTH OF WHICH 12 ARE WITHIN PHILIPPINE JURISDICTION, SHALL AT ALL TIMES 13 **BE PROHIBITED."** 14

16 "SECTION 5. THE PORT OF ENTRY OF THE ASEAN-REGISTERED
 17 RIGHT HAND-DRIVE MOTOR VEHICLES SPECIALLY EXEMPTED
 18 UNDER THIS ACT SHALL BE RESTRICTED TO THE DECLARED
 19 INTERNATIONAL PORTS IN MINDANAO AND PALAWAN, AND
 20 SUCH OTHER INTERNATIONAL PORTS AS MAY LATER BE
 21 RECOGNIZED BY THE DEPARTMENT OF TRANSPORTATION."

"SECTION 6. UNLESS OTHERWISE EXEMPTED UNDER ANY 23 INTERNATIONAL AGREEMENT OR CONVENTION AS WITH ASEAN 24 PASSPORT-HOLDERS, DRIVERS OF ASEAN-REGISTERED RIGHT 25 HAND-DRIVE MOTOR VEHICLES SPECIALLY EXEMPTED UNDER 26 THIS ACT SHALL BE REQUIRED TO PRESENT PHILIPPINE VISAS: 27 PROVIDED, THAT THEIR PASSPORTS SHALL AT ALL TIMES BE 28 VALID UNDER PHILIPPINE LAWS, RULES AND REGULATIONS 29 WITHIN THE DURATION OF THEIR STAY IN THE COUNTRY." 30

"SECTION 7. FOR THE SAFETY, CONVENIENCE, AND SECURITY

OF VISITORS AND PHILIPPINE RESIDENTS, THE PRIVILEGES 1 GRANTED UNDER THIS ACT SHALL AT ALL TIMES BE LIMITED BY 2 CUSTOMS, PHILIPPINE LAND TRANSPORTATION, 3 SECURITY, AND **OTHER** QUARANTINE, IMMIGRATION, 4 APPLICABLE LAWS, RULES AND REGULATIONS." 5 6 SECTION 4. Sections 2 and 3 of Republic Act No. 8506 are hereby renumbered 7 as Sections 8 and 9 to read as follows: 8 9 "Section [2] 8.
