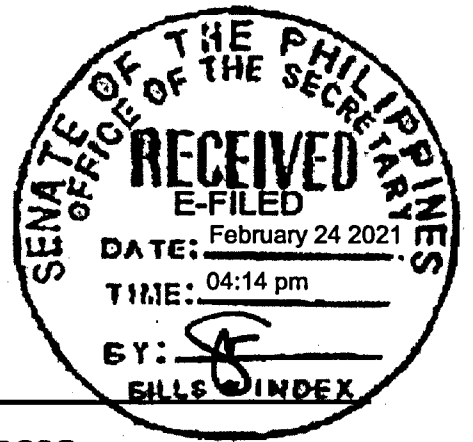

AN ACT SEPARATING THE SITIOS OF KAINGGIAN, BUTAC, COSCOSNONG, LONGBOY, BANGCAG, AND BOTIGUE FROM BARANGAY MAN-ATONG IN THE MUNICIPALITY OF SUYO, PROVINCE OF ILOCOS SUR AND CONSTITUTING IT INTO A DISTINCT AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY BUTAC

EXPLANATORY NOTE

Section 9 of Article II of the 1987 Philippine Constitution provides that *"The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all."*


The Municipality of Suyo is a 4th class municipality in the Province of Ilocos Sur. The Philippine Statistics Authority (PSA) conducted the census-taking for the 2015 Census of Population (POPCEN 2015) in August to September 2015. According to POPCEN 2015, Suyo is politically subdivided into eight (8) barangays only while it has a population of 11,446 people.

Republic Act 7160 or the Local Government Code of the Philippines provides that the barangay serves as the primary planning and implementing unit of government policies, plans, programs, projects, and activities in the community, and as a forum wherein the collective views of the people may be expressed, crystallized and considered, and where disputes may be amicably settled. Hence, to efficiently implement the role of the barangay, the number of constituents per barangay must be proportioned accordingly.

This bill therefor seeks the creation of a new barangay to be known as Barangay Butac in the Municipality of Suyo, Ilocos Sur by separating Sitios Kainggian, Butac, Coscosnong, Longboy, Bangcag, and Botigue from the mother barangay, Barangay Man-atong, Suyo, Ilocos Sur. Further, this bill aims to make government programs, services, and facilities closer to the constituents by creating a new barangay. This is

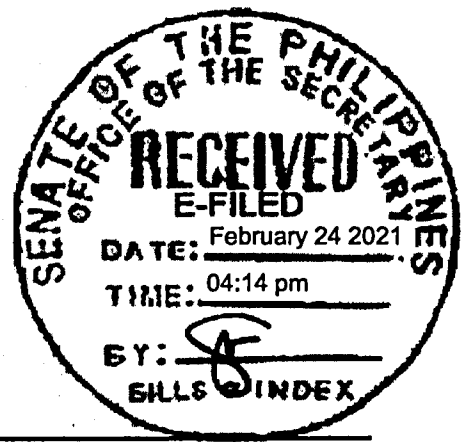
also deemed relevant to meet the demand for socio-economic development and more efficient access to government resources especially during this time of pandemic. Hence,

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** *Creation of Barangay Butac.* – The sitios of Kainggian, Butac,
2 Coscosnong, Longboy, Bangcag and Botigue in Barangay Mang-Atong, Municipality of
3 Suyo, Province of Ilocos Sur are hereby separated from Barangay Man-atong and
4 constituted as a distinct and independent barangay to be known as Barangay Butac.

5 **SEC. 2.** *Territorial Boundaries.* – The territorial boundaries of Barangay Butac
6 are hereby described as follows:

10 **SEC. 3. *Conduct and Supervision of Plebiscite.*** – Pursuant to Section 10 Republic
11 Act No. 7160, otherwise known as the Local Government Code of 1991, as amended,
12 the new Barangay Butac shall exist upon the approval of a majority of qualified voters
13 of Barangay Man-atong through the votes cast in a plebiscite to be conducted and
14 supervised by the Commission on Elections (COMELEC) within ninety (90) days from
15 the effectivity of this Act.

16 The expenses for the plebiscite shall be borne by the Municipality of Suyo,
17 Province of Ilocos Sur.

18 **SEC. 4. *Barangay Officials.*** – The first set of barangay officials of Barangay Butac
19 shall be appointed by the President of the Philippines and shall hold office until such
20 time that a new set of officers have been duly elected and qualified.

21 **SEC. 5. *Public Infrastructure and Facilities.*** – All public infrastructure and
22 facilities existing therein at the time of the approval of this Act are hereby transferred
23 without cost or compensation to and shall be administered by the new Barangay
24 Butac.

25 **SEC. 6. *Internal Revenue Allotment Shares.*** – Barangay Butac shall be entitled
26 to Internal Revenue Allotment (IRA) shares pursuant to Section 285 of the Local
27 Government Code of 1991, as amended.

28 **SEC. 7. *Effectivity.*** – This Act shall take effect effect fifteen (15) days after its
29 publication in the *Official Gazette* or in a newspaper of general circulation.
