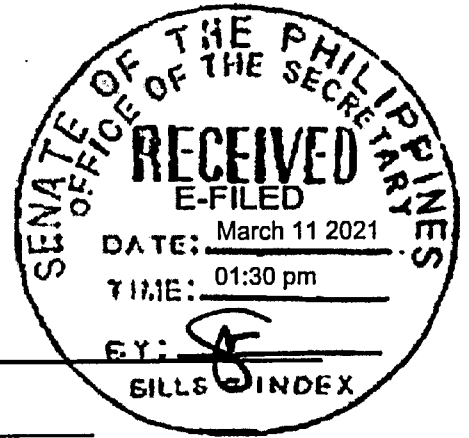

RENAMING DEL MONTE AVENUE, TRAVERSING BARANGAYS NAYONG  
KANLURAN, PALTOK, PARAISO, DEL MONTE, DAMAYAN, MASAMBONG,  
TALAYAN, MANRESA, SIENA, ST. PETER, SAN JOSE AND N.S. AMORANTO,  
LOCATED IN LEGISLATIVE DISTRICT I OF QUEZON CITY, AS  
FERNANDO POE JR. AVENUE

*Be it enacted by the Senate and the House of Representatives in Congress assembled:*

**SECTION 1.** The Del Monte Avenue, traversing Barangays Nayong Kanluran, Paltok, Paraiso, Del Monte, Damayan, Masambong, Talayan, Manresa, Siena, St. Peter, San Jose and N.S. Amoranto, located in Legislative District I of Quezon City, is hereby renamed as Fernando Poe Jr. Avenue.

**SEC.2.** The Department of Public Works and Highways shall issue the necessary rules, orders, and circulars to implement the provisions of this Act within sixty (60) days from its effectivity.

**SEC.3.** This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
