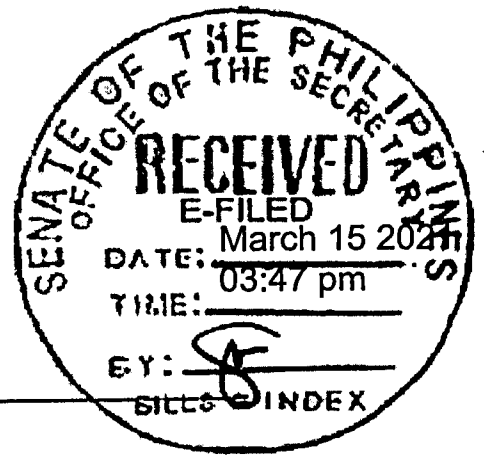

Recommending its approval with amendments.

MR. PRESIDENT:

The Committee on Public Services, to which was referred **House Bill No. 8555**, introduced by **Representatives Escudero, Alvarez (F.), Maceda, Garbin, Dy (F.), et. al.**, entitled:

AN ACT
GRANTING GOOD NEWS SORSOGON FOUNDATION, INC., A
FRANCHISE TO CONSTRUCT, INSTALL, OPERATE, AND MAINTAIN
RADIO AND TELEVISION BROADCASTING STATIONS IN THE BICOL
REGION

has considered the same and has the honor to report back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 4, Section 10, line 7, delete the phrase 'its regularized employees and secure a compliance and clearance' and replace it with '**TRAINEES AND WORKERS WHOSE EMPLOYMENT STATUS ARE MADE REGULAR, AND APPEND THE APPROPRIATE**'

On the same page, line 8, delete the phrase 'and its relevant attached agencies' and replace it with '**ATTESTING THAT IT HAS COMPLIED WITH THE EMPLOYMENT REQUIREMENT UNDER THIS SECTION.**'

The last paragraph of Section 10 shall now read as follows:

The employment opportunities or jobs created shall be reflected in the General Information Sheet (GIS) to be submitted to the Securities and Exchange Commission (SEC) annually. In addition, the grantee shall include in its annual

report to Congress the number of **TRAINEES AND WORKERS WHOSE EMPLOYMENT STATUS ARE MADE REGULAR, AND APPEND THE APPROPRIATE** certificate from the Department of Labor and Employment **ATTESTING THAT IT HAS COMPLIED WITH THE EMPLOYMENT REQUIREMENT UNDER THIS SECTION."**

2. On the same page, line 26, delete the word 'common' and replace it with '**OUTSTANDING CAPITAL**'.
