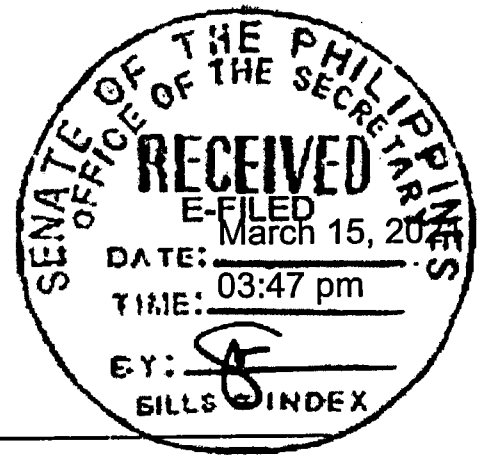

Re: **House Bill No. 8860**

Recommending its approval with amendments, taking into consideration **Senate Bill No. 2059**

MR. PRESIDENT:

The Committee on Public Services, to which were referred **House Bill No. 8860**, introduced by **Representatives Zubiri, Acosta-Alba, Alvarez (F.), Maceda, et. al.**, entitled:

AN ACT
GRANTING HIGHLAND BROADCASTING NETWORK CORP. A FRANCHISE TO CONSTRUCT, INSTALL, ESTABLISH, OPERATE, AND MAINTAIN RADIO AND TELEVISION BROADCASTING STATIONS IN MINDANAO

and **Senate Bill No. 2059**, introduced by **Sen. Juan Miguel "Migz" F. Zubiri**, entitled:

AN ACT
GRANTING THE HIGHLAND BROADCASTING NETWORK CORP. A FRANCHISE TO CONSTRUCT, INSTALL, ESTABLISH, OPERATE AND MAINTAIN RADIO AND TELEVISION BROADCASTING STATIONS IN MINDANAO

has considered the same and has the honor to report back to the Senate with the recommendation that **House Bill No. 8860**, taking into consideration **Senate Bill No. 2059**, be approved with the following amendments:

1. On page 3, Section 10, line 43, delete the phrase '**job order workers, casual employees, and contract of service**' and replace it with '**AND**'.

The last paragraph of Section 10 shall now read as follows:

"The employment opportunities or jobs created shall be reflected in the General Information Sheet (GIS) to be submitted to the Securities and Exchange Commission (SEC) annually. In addition, the grantee shall include in its annual report to Congress the number of trainees **AND** workers whose employment status are made regular, and append the appropriate certificate from the Department of Labor and Employment attesting that it has complied with the employment requirement under this Section."

2. On page 4, line 14, delete the word 'common' and replace it with '**OUTSTANDING CAPITAL**'.






