AN ACT

SEPARATING THE MARIANO PERALTA NATIONAL HIGH SCHOOL – SANGAY EXTENSION IN BARANGAY SANGAY, MUNICIPALITY OF MALITA, PROVINCE OF DAVAO OCCIDENTAL FROM THE MARIANO PERALTA NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS ERNESTO LOPEZ NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Mariano Peralta National High School – Sangay Extension in
2 Barangay Sangay, Municipality of Malita, Province of Davao Occidental is hereby separated
3 from the Mariano Peralta National High School and converted into an independent national
4 high school to be known as Ernesto Lopez National High School.
5

6 **SEC. 2.** All personnel, assets, liabilities and records of the Mariano Peralta National
7 High School – Sangay Extension are hereby transferred to and absorbed by the Ernesto Lopez
8 National High School.
9

10 **SEC. 3.** The Secretary of Education shall immediately include in the Department's
11 program the operationalization of the Ernesto Lopez National High School, the initial funding
12 of which shall be charged against the current year's appropriation of the Mariano Peralta
13 National High School – Sangay Extension. Thereafter, the amount necessary for the continued
14 operation of the school shall be included in the annual General Appropriations Act.

16 **SEC. 4.** Within one hundred twenty days (120) days after the approval of this Act, the
17 Secretary of Education shall promulgate the rules and regulations implementing the provisions
18 of this Act.

20 **SEC. 5.** This Act shall take effect fifteen (15) days after its publication in the *Official*
21 *Gazette* or in a newspaper of general circulation.
