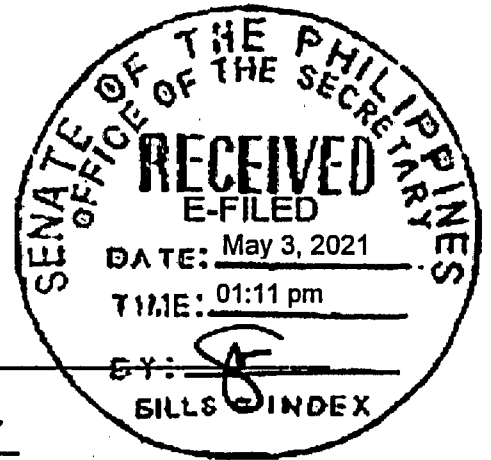

Recommending its approval with amendments, taking into consideration Senate Bill No. 1576.

MR. PRESIDENT:

The Committees on Basic Education, Arts and Culture; and Finance, to which were referred **House Bill No. 4955**, introduced by Representatives Cari, Romulo and Ungab, entitled:

"AN ACT

ESTABLISHING A NATIONAL JUNIOR HIGH SCHOOL IN BARANGAY PUNTA, BAYBAY CITY, PROVINCE OF LEYTE TO BE KNOWN AS PUNTA JUNIOR HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR"

and taking into consideration **Senate Bill No. 1576**, introduced by Senator Imee R. Marcos, entitled:

**"AN ACT
ESTABLISHING A NATIONAL JUNIOR HIGH SCHOOL IN
BARANGAY PUNTA, BAYBAY CITY, PROVINCE OF LEYTE TO
BE KNOWN AS PUNTA JUNIOR HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR"**

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 4955, taking into consideration Senate Bill No. 1576, be approved with the following amendments:

1. In line 2, after the word "national", delete the word "junior".
2. In line 4, after the name "Punta", replace the word "Junior" with the word **"NATIONAL"**.
3. Finally, amend the title to read as follows:



AN ACT ESTABLISHING A NATIONAL JUNIOR HIGH SCHOOL IN
BARANGAY PUNTA, BAYBAY CITY, PROVINCE OF LEYTE TO
BE KNOWN AS PUNTA JUNIOR HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established, under the
2 supervision of the Department of Education, a national junior high
3 school in Barangay Punta, Baybay City, Province of Leyte to be
4 known as Punta Junior High School.

5 SEC. 2. The Secretary of Education shall immediately include
6 in the Department's program the operationalization of the Punta
7 Junior High School, the funding of which shall be included in the
8 annual General Appropriations Act.

9 SEC. 3. Within one hundred twenty (120) days from the
10 approval of this Act, the Secretary of Education shall formulate the
11 rules and regulations implementing the provisions of this Act.

12 SEC. 4. This Act shall take effect fifteen (15) days after its
13 publication in the *Official Gazette* or in a newspaper of general
14 circulation.
