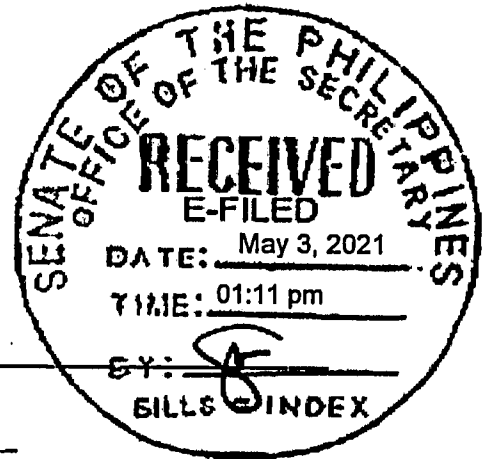

AND APPROPRIATING FUNDS THEREFOR"**



AN ACT  
ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY MARCOS,  
MUNICIPALITY OF SANTA, PROVINCE OF ILOCOS SUR TO BE KNOWN AS  
THE SANTA NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS  
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There is hereby established, under the supervision of the Department of  
2 Education, a national high school in Barangay Marcos, Municipality of Santa, Province of  
3 Ilocos Sur to be known as the Santa National High School.

4  
5           SEC. 2. The Secretary of Education shall immediately include in the Department's  
6 program the operationalization of the Santa National High School, the funding of which shall  
7 be included in the annual General Appropriations Act.

8  
9           SEC. 3. Within sixty (60) days from the approval of this Act, the Secretary of  
10 Education shall formulate and issue the rules and regulations implementing the provisions of  
11 this Act.

12  
13           SEC. 4. This Act shall take effect fifteen (15) days after its publication in the *Official*  
14 *Gazette* or in a newspaper of general circulation.
