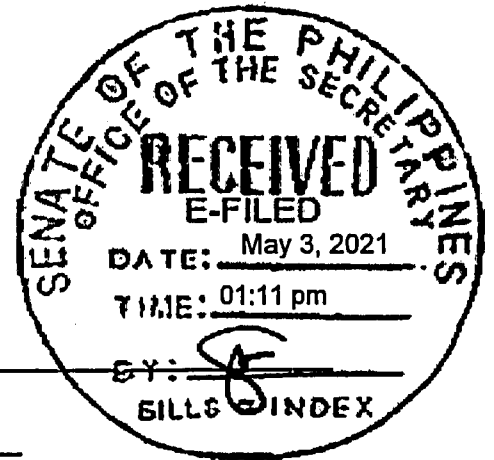

COMMITTEE REPORT NO. 251

Submitted jointly by the Committees on Basic Education, Arts and Culture; and Finance on May 3, 2021.

Re: House Bill No. 4954.

Recommending its approval with amendments, taking into consideration Senate Bill No. 1575.

Sponsor: Senator Win Gatchalian

MR. PRESIDENT:

The Committees on Basic Education, Arts and Culture; and Finance, to which were referred **House Bill No. 4954**, introduced by Representatives Cari, Romulo and Ungab, entitled:

"AN ACT

ESTABLISHING A NATIONAL JUNIOR HIGH SCHOOL IN BARANGAY MAGANHAN, BAYBAY CITY, PROVINCE OF LEYTE TO BE KNOWN AS MAGANHAN JUNIOR HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR"

and taking into consideration **Senate Bill No. 1575**, introduced by Senator Imee R. Marcos, entitled:

**"AN ACT
ESTABLISHING A NATIONAL JUNIOR HIGH SCHOOL IN
BARANGAY MAGANHAN, BAYBAY CITY, PROVINCE OF LEYTE
TO BE KNOWN AS MAGANHAN JUNIOR HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR"**

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 4954, taking into consideration Senate Bill No. 1575, be approved with the following amendments:

1. In line 2, after the word "Education", insert "**(DEPED)**".
2. Still in line 2, after the word "national", delete the word "junior".
3. In line 3, replace "Baybay City" with "**CITY OF BAYBAY**".
4. In line 4, after the name "Maganhan", replace the word "Junior" with the word "**NATIONAL**".
5. In lines 5 to 8, delete the entire Section 2 and replace it with a new Section 2 to read as follows:

"SEC. 2. THE AMOUNT NECESSARY FOR THE OPERATIONALIZATION OF THE MAGANHAN NATIONAL HIGH SCHOOL SHALL BE CHARGED AGAINST THOSE AUTHORIZED IN THE CURRENT APPROPRIATIONS OF THE DEPED. THEREAFTER, THE AMOUNT NECESSARY FOR THE IMPLEMENTATION OF THIS ACT SHALL BE INCLUDED IN THE ANNUAL GENERAL APPROPRIATIONS ACT."

6. In line 10, delete the phrase "Secretary of Education" and replace it with **"DEPED, IN COORDINATION WITH THE LOCAL GOVERNMENTS OF THE CITY OF BAYBAY AND BARANGAY MAGANHAN,"**.
7. Still in line 10, after the word "shall", replace the word "formulate" with the word **"ISSUE"**.
8. After line 11, insert a new Section 4 to read as follows:

"SEC. 4. ALL OTHER LAWS, DECREES, EXECUTIVE ORDERS, RULES AND REGULATIONS AND OTHER ISSUANCES INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR AMENDED ACCORDINGLY."

9. Renumber the succeeding Section accordingly.
10. Finally, amend the title to read as follows:

**"AN ACT
ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY
MAGANHAN, CITY OF BAYBAY, PROVINCE OF LEYTE TO BE KNOWN
AS MAGANHAN NATIONAL HIGH SCHOOL AND APPROPRIATING
FUNDS THEREFOR"**

AN ACT ESTABLISHING A NATIONAL JUNIOR HIGH SCHOOL
IN BARANGAY MAGANHAN, BAYBAY CITY, PROVINCE
OF LEYTE TO BE KNOWN AS MAGANHAN JUNIOR HIGH
SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established, under the
2 supervision of the Department of Education, a national junior high
3 school in Barangay Maganhan, Baybay City, Province of Leyte to be
4 known as Maganhan Junior High School.

5 SEC. 2. The Secretary of Education shall immediately include
6 in the Department's program the operationalization of the
7 Maganhan Junior High School, the funding of which shall be
8 included in the annual General Appropriations Act.

9 SEC. 3. Within one hundred twenty (120) days from the
10 approval of this Act, the Secretary of Education shall formulate the
11 rules and regulations implementing the provisions of this Act.

12 SEC. 4. This Act shall take effect fifteen (15) days after its
13 publication in the *Official Gazette* or in a newspaper of general
14 circulation.
