Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 1 of Republic Act No. 8256 is hereby amended to read as follows:

"SECTION 1. The foundation days and feast days [of] IN the
Province of Davao Oriental, and the CITIES, municipalities, AND
BARANGAYS therein are hereby declared as special nonworking public
holidays."

6 SEC. 2. This Act shall take effect fifteen (15) days after its publication in the Official 7 Gazette or in a newspaper of general circulation.
