AN ACT

DECLARING JUNE 10 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY IN THE PROVINCE OF TARLAC TO BE KNOWN AS "DANDING COJUANGCO DAY", IN COMMEMORATION OF THE BIRTH ANNIVERSARY OF EDUARDO "DANDING" MURPHY COJUANGCO, JR.

*Be it enacted by the Senate and the House of Representatives
of the Philippines in Congress assembled:*

1 SECTION 1. June 10 of every year is hereby declared a special non-working holiday in
2 the Province of Tarlac to be known as "*Danding Cojuangco Day*", in commemoration of the
3 birth anniversary of Eduardo "*Danding*" Murphy Cojuangco, Jr.

5 SEC. 2. This Act shall take effect fifteen (15) days after its publication in the *Official*
6 *Gazette* or in a newspaper of general circulation.
