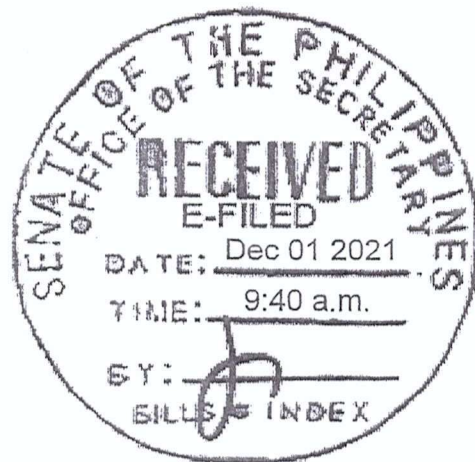

AN ACT DECLARING JULY 2 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN PASIG CITY TO BE KNOWN
AS THE "ANNIVERSARY DAY OF PASIG CITY"

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. July 2 of every year is hereby declared a special
2 nonworking holiday in Pasig City to be known as the "Anniversary
3 Day of Pasig City".

4 SEC. 2. This Act shall take effect fifteen (15) days after its
5 publication in the *Official Gazette* or in a newspaper of general
6 circulation.
