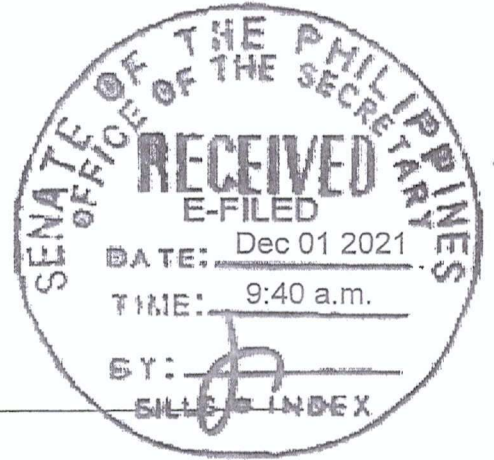

AN ACT

DECLARING SEPTEMBER 20 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY IN THE PROVINCE OF ILOCOS NORTE TO BE KNOWN AS "JOSEFA LLANES-ESCODA DAY", IN COMMEMORATION OF HER BIRTH ANNIVERSARY

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

SECTION 1. September 20 of every year is hereby declared a special non-working holiday in the Province of Ilocos Norte to be known as "*Josefa Llanes-Escoda Day*", in commemoration of her birth anniversary.

SEC. 2. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
