Introduced by Representatives Frederick W. Siao, Mark O. Go, Eric Go Yap, and Joey Sarte Salceda

AN ACT
CONVERTING THE ILIGAN CITY NATIONAL SCHOOL OF FISHERIES (ICNSF) IN BARANGAY BURU-UN, ILIGAN CITY, PROVINCE OF LANA DEL NORTE, INTO A POLYTECHNIC STATE COLLEGE, TO BE KNOWN AS THE ILIGAN CITY POLYTECHNIC STATE COLLEGE (ICPSC), AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** *Conversion of the Iligan City National School of Fisheries into a*
2 *Polytechnic State College.* – The Iligan City National School of Fisheries (ICNSF) located in
3 Barangay Buru-un, Iligan City, Province of Lanao del Norte, is hereby converted into a
4 polytechnic state college, to be known as the Iligan City Polytechnic State College (ICPSC). Its
5 main campus shall be in Iligan City.
6

7 **SEC. 2. General Mandate.** – The ICPSC, hereinafter referred to as the College, shall
8 primarily provide advance instruction and professional training in education, engineering,
9 science and technology, arts and humanities, information and communications technology,
10 agriculture, forestry, and other relevant fields of study. It shall also undertake research and
11 extension services and production activities in support of the socio-economic development of the
12 Province of Lanao del Norte and Region X.
13

14 **SEC. 3. Curricular Offerings.** – The College shall offer short-term technical vocational,
15 undergraduate, and graduate courses, within its competency and areas of specialization in the
16 fields of education, engineering, science and technology, arts and humanities, information and
17 communications technology, agriculture, forestry, fishery education, marine transportation, and
18 tourism. It shall also offer vocational and technology courses in welding technology, vocational
19 technology, hotel and restaurant services, hotel and household services, baking technology,
20 electronic services and repair, and other relevant fields of study, as the Board of Trustees,

1 hereinafter referred to as the Board, may deem necessary for the accomplishment of the
2 objectives of the College, and those which respond to the human resource development needs of
3 the Province of Lanao del Norte and Region X.
4

5 The existing and any other future technical-vocational courses or programs under the
6 supervision of the Technical Education and Skills Development Authority (TESDA) shall
7 continue to be offered in the College.
8

9 The existing reasonably-sized laboratory junior and senior high school and elementary
10 school shall continue to operate under the supervision of the College of Education to serve the
11 in-campus requirements of its students.
12

13 **SEC. 4. Administration** – The College shall have the general powers of a corporation
14 set forth in Batas Pambansa Blg. 68, otherwise known as “The Corporation Code of the
15 Philippines”, as amended. The exercise of its corporate powers shall be vested exclusively in the
16 Board and the President of the College.
17

18 **SEC. 5. The Governing Board.** – The governing body of the College shall be the Board,
19 which shall be chaired and co-chaired by the Chairperson of the Commission on Higher
20 Education (CHED) and the President of the College, respectively, and with the following as
21 members:
22

- 23 a. Chairperson of the Committee on Higher, Technical and Vocational Education of the
24 Senate;
- 25 b. Chairperson of the Committee on Higher and Technical Education of the House of
26 Representatives;
- 27 c. Regional Director of the National Economic and Development Authority;
- 28 d. Regional Director of the Department of Science and Technology;
- 29 e. Regional Director of the Department of Agriculture;
- 30 f. Regional Director of the TESDA;
- 31 g. President of the federation of faculty associations of the College;
- 32 h. President of the federation of student councils of the College;
- 33 i. President of the federation of alumni associations of the College; and
- 34 j. Two (2) prominent citizens from the private sector who have distinguished
35 themselves in their professions or fields of specialization.
36

37 The Board shall appoint two (2) prominent citizens who shall be selected from a list of at
38 least five (5) qualified persons from the Province of Lanao del Norte, as recommended by a
39 search committee. The Search Committee is constituted by the President of the College, in
40 consultation with the Chairperson of the CHED and other members of the Board, based on the
41 standards and qualifications for the position set by the Board. They shall serve for a term of two
42 (2) years from the date of appointment.
43

44 The membership of the President of the federation of faculty associations, the President
45 of the federation of student councils, and the President of the federation of alumni associations in

1 the Board shall be coterminous with their terms of office, as provided under their respective
2 constitutions and bylaws.
3

4 **SEC. 6. Powers and Duties of the Board of Trustees.** – In addition to its general powers
5 of administration and the powers granted to the board of directors of a corporation under existing
6 laws, the Board shall have the following specific powers and duties:
7

- 8 a. Promulgate and implement policies in accordance with the declared State policies on
9 education, other pertinent provisions of the Constitution on education, agriculture,
10 science and technology, and the policies, standards and thrusts of the CHED under
11 Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994", and
12 also in accordance with the policies, standards and programs of the TESDA, under
13 Republic Act No. 7796, otherwise known as the "TESDA Act of 1994";
14
- 15 b. Approve the curricula, instructional programs, and rules on student discipline drawn
16 by the Administrative and Academic Councils as herein provided;
17
- 18 c. Appoint, upon the recommendation of the President of the College, the vice
19 presidents, deans, directors, heads of the campuses, faculty members, and other
20 officials and employees of the College;
21
- 22 d. Fix and adjust the salaries of faculty members, administrative officials and
23 employees, subject to the provisions of the Revised Compensation and Position
24 Classification System and other pertinent budget and compensation laws governing
25 hours of service, and such other duties and conditions as it may deem proper; grant
26 them, at its discretion, leaves of absence under such regulations as it may promulgate,
27 any provision of existing law to the contrary notwithstanding; and remove them for
28 cause in accordance with the requirements of due process of law;
29
- 30 e. Fix the tuition fees and other necessary school charges, such as matriculation fees,
31 graduation fees and laboratory fees, as the Board may deem proper to impose, after
32 due consultation with the concerned sectors. The fees and charges, including
33 government subsidies and other income generated by the College, shall constitute its
34 special trust funds and shall be deposited in any authorized government depository
35 bank. All interests that shall accrue therefrom shall form part of the same funds for
36 the use of the College.
37

38 Any provision of existing laws, rules or regulations to the contrary
39 notwithstanding, any income generated by the College from tuition fees and other
40 charges, as well as from the operation of auxiliary services and land grants, shall be
41 retained by the College and may be disbursed by the Board for instruction, research,
42 extension services or other programs and projects of the College: *Provided*, That all
43 fiduciary fees shall be disbursed for the specific purposes for which these are
44 collected: *Provided, however*, That if, for reasons beyond its control, the College
45 shall not be able to pursue any project for which the funds have been appropriated
46 and allocated under its approved program of expenditures, the Board may authorize

1 the use of said funds for any reasonable purpose which, in its discretion, may be
2 necessary and urgent for the attainment of the objectives and goals of the College;

3
4 f. Adopt and implement a socialized scheme of tuition and other school fees for greater
5 access of poor but deserving students in accordance with Republic Act No. 10931 or
6 the "Universal Access to Quality Tertiary Education Act";

7
8 g. Establish professorial chairs in the College and provide fellowships for qualified
9 faculty members, and scholarships to deserving students;

10
11 h. Receive and appropriate sums as may be provided by law for the support of the
12 College, and all other sums in the manner it may, in its discretion, determine to carry
13 out the purposes and functions of the College;

14
15 i. Set the policies on admission and graduation of students;

16
17 j. Award honorary degrees upon persons in recognition of their outstanding
18 contributions in the fields of education, public service, arts, science and technology,
19 agriculture or any field of specialization within the academic competency of the
20 College, and authorize the awarding of certificates of completion of nondegree and
21 nontraditional courses;

22
23 k. Establish research and extension centers to promote the development of the College;

24
25 l. Develop academic arrangements for institutional capability building with appropriate
26 institutions and agencies, whether public, private, local or foreign, and appoint
27 experts or specialists as consultants, part-time, visiting or exchange professors,
28 scholars or researchers, as the case may be;

29
30 m. Adopt modern and innovative modes of transmitting knowledge for the promotion of
31 greater access to education such as the use of information technology, dual training
32 system, open distance learning, and community laboratory;

33
34 n. Collaborate with the governing bodies of other colleges within the Province of Lanao
35 del Norte and Region X, under the supervision of the CHED and in consultation with
36 the Department of Budget and Management (DBM), in restructuring the College to
37 make it more efficient, relevant, productive and competitive;

38
39 o. Absorb non chartered tertiary institutions within the province of Lanao del Norte and
40 Region X as branches and extension/external centers, in coordination with the CHED
41 and in consultation with the DBM, and offer therein programs or courses to carry out
42 the constitutional mandate of providing equal access to educational opportunities;

43
44 p. Authorize an external management audit of the College, to be financed by the CHED,
45 subject to the rules and regulations of the Commission on Audit, and institute

1 reforms, including academic and structural changes, on the basis of the audit results
2 and recommendations;

3
4 q. Develop consortia and other economic forms of linkages with local government units
5 (LGUs), as well as public, private, local or foreign institutions and agencies, in the
6 furtherance of the purposes and objectives of the College;

7
8 r. Import economic, technical and cultural books and publications;

9
10 s. Enter into joint ventures with business and industry for the profitable development
11 and management of economic assets, the proceeds of which shall be used for the
12 development and strengthening of the College;

13
14 t. Receive in trust, legacies, gifts and donations of real and personal properties of all
15 kinds and administer and dispose of the same, when necessary, for the benefit of the
16 College and subject to the limitations, directions and instructions of the donor, if any;

17
18 u. Extend the term of the President of the College beyond the age of retirement, but not
19 beyond the age of seventy (70), based on the guidelines, qualifications and standards
20 set by the Board: *Provided*, That the President's performance has been rated by the
21 Board as outstanding and a unanimous recommendation for such extension has been
22 decided upon by the search committee;

23
24 v. Delegate any of its powers and duties provided to the President and other officials of
25 the College, as it may deem appropriate, so as to expedite the administration of the
26 affairs of the College;

27
28 w. Establish policy guidelines and procedures for participative and transparent decision-
29 making within the College;

30
31 x. Where most advantageous to the College, privatize the management of nonacademic
32 services such as health, food, building grounds or property maintenance, and such
33 other similar activities;

34
35 y. Authorize the construction or repair of its buildings, machinery, equipment and other
36 facilities, and the purchase and acquisition of real property, including the necessary
37 supplies, materials and equipment; and

38
39 z. Promulgate rules and regulations, as may be necessary, to carry out the purposes and
40 functions of the College.

41
42 **SEC. 7. Meetings of the Board.** – The Board shall regularly convene once every three
43 (3) months. The Chairperson of the Board may, however, call a special meeting whenever
44 necessary: *Provided*, That members are notified in writing at least three (3) days prior to the
45 conduct of said meeting.
46

1 A quorum of the Board shall consist of a majority of all its members holding office at the
2 time of the meeting: *Provided, however,* That the Chairperson of the Board or the President of
3 the College is among those present in the meeting.
4

5 In case the Chairperson of the CHED cannot attend a meeting of the Board, a CHED
6 Commissioner duly designated by the Chairperson of the CHED as representative to the meeting,
7 shall have all the rights and responsibilities of a regular member: *Provided,* That during the
8 meeting, the President of the College, as Vice Chairperson, shall be the presiding officer:
9 *Provided, further,* That this provision notwithstanding, the Chairperson of the CHED is hereby
10 authorized to designate a CHED Commissioner as the regular Chairperson of the Board, in
11 which case, the said CHED Commissioner shall act as the presiding officer.
12

13 In case the Chairpersons of the Senate Committee on Higher, Technical and Vocational
14 Education and the House Committee on Higher and Technical Education will not be able to
15 attend the Board meeting, they may designate their respective representatives to attend the
16 meeting, who shall have the same rights and responsibilities as regular members of the Board.
17

18 The members of the Board shall not receive any salary, but shall be entitled to
19 reimbursements for actual and necessary expenses incurred, either for their attendance to the
20 meetings of the Board or in connection with other official business authorized by resolutions of
21 the Board, subject to existing laws and regulations.
22

23 **SEC. 8. *The College President.*** – The College shall be headed by a President who shall
24 be appointed by the Board, subject to its guidelines on qualifications and standards, and based on
25 the recommendation of a search committee duly constituted for the purpose of selecting the
26 President.
27

28 The President shall render full-time service and shall have a terms of four (4) years, but
29 may be reappointed to another term: *Provided,* That in order to effect the smooth transition of the
30 vocational school to a polytechnic state college, the incumbent President of the ICNSF, if
31 qualified, shall serve as the first President of the College.
32

33 Within six (6) months before the expiration of the term of office of the incumbent
34 President of the College, the Board shall constitute the search committee for the Presidency.
35

36 The powers and duties of the President of the College, in addition to those specifically
37 provided in this Act, shall be those usually pertaining to the Office of the President of colleges
38 and those delegated by the Board.
39

40 The salary of the President of the College shall be in accordance with Republic Act No.
41 11466 or the “Salary Standardization Law of 2019”, and by such other laws amendatory thereto,
42 which may hereinafter be enacted, and shall be comparable to that being received by the
43 presidents of similar educational institutions.
44

45 The Board shall designate an Officer-in-Charge of the College in case of a vacancy in the
46 Office of the President by reason of death, compulsory retirement, resignation, removal for

1 cause, or incapacity of the President to perform the functions of the office, pending the
2 appointment of a new President: *Provided*, That the Officer-in-Charge shall serve only during the
3 unexpired portion of the term.
4

5 The President of the College shall be assisted by a Vice President for Academic Affairs, a
6 Vice President for Administration, and a Vice President for Research, Development and
7 Extension, who shall all be appointed by the Board upon the recommendation of the President of
8 the College.
9

10 **SEC. 9. *The Secretary of the College.*** – The Board shall appoint a Secretary who shall
11 serve as such for both the Board and the College and shall keep all records and proceedings of
12 the Board. The Secretary of the College shall serve upon each member of the Board the
13 appropriate notice of board meetings.
14

15 **SEC. 10. *The Treasurer of the College.*** – The Treasurer of the Philippines shall be the
16 *ex officio* Treasurer of the College.
17

18 **SEC. 11. *The Administrative Council.*** – There shall be an Administrative Council
19 consisting of the President of the College as chairperson, and the vice presidents, deans, directors
20 and other officials of equal rank as members, that shall review and recommend to the Board the
21 policies that shall govern the administration, management and development planning of the
22 College.
23

24 **SEC. 12. *The Academic Council.*** – There shall be an Academic that shall formulate
25 academic policies. It shall be composed of the President of the College, who shall act as
26 chairperson, and all academic staff with the rank of at least an assistant professor, as members.
27

28 The Academic Council shall also have the power to review and recommend the curricular
29 offerings and rules on student discipline, subject to the approval of the Board. It shall fix the
30 requirements for the admission of students, as well as for their graduation and conferment of
31 degrees, subject to the review and approval of the Board through the President of the College.
32

33 It shall exercise disciplinary power over the students of the College and shall formulate
34 rules and regulations on student discipline, subject to the approval of the Board.
35

36 **SEC. 13. *The Faculty.*** – No political belief, gender preference, cultural or community
37 affiliation or ethnic origin, nor religious opinion or affiliation shall be a matter of inquiry in the
38 appointment of faculty members of the College: *Provided*, That said appointment shall be subject
39 to the guidelines, qualifications, and standards set by the Board: *Provided, further*, That no
40 member of the faculty shall teach for or against any particular church or religious sect.
41

42 **SEC. 14. *Academic Freedom and Institutional Autonomy.*** – The College shall enjoy
43 academic freedom and institutional autonomy pursuant to paragraph 2, Section 5 of Article XIV
44 of the Constitution.
45

46 **SEC. 15. *Scholarship Programs and Admision.*** – The College shall provide

1 scholarship and other affirmative action programs to assist poor but deserving students who
2 qualify for admission to the College.
3

4 No student shall be denied admission to the College by reason of gender, religion,
5 cultural or community affiliation, physical disability or ethnic origin.
6

7 **SEC. 16. Authority to Loan or Transfer Apparatus, Equipment, Supplies and Detail of**
8 **Personnel.** – The heads of the bureaus and offices of the national government are hereby
9 authorized to loan or transfer, upon the request of the President of the College, such apparatus,
10 equipment or supplies as may be needed by the College, and detail employees for duty therein
11 when, in the judgment of the head of bureau or office, such apparatus, equipment, supplies or
12 service of such employees can be spared without serious detriment to public service.
13

14 The employees so detailed shall perform such duties as required of them by the President
15 of the College and the time thus served shall be counted as part of their regular service.
16

17 **SEC. 17. Assets, Liabilities and Personnel.** – All assets, real and personal, personnel,
18 and records of the ICNSF as well as liabilities or obligations, are hereby transferred to the
19 College: *Provided*, That the positions, rights and security of tenure of faculty members and
20 personnel therein employed under existing laws prior to the conversion into a college shall be
21 respected: *Provided, further*, That the incumbents of the positions shall remain in the same status
22 until otherwise provided for by the Board: *Provided, finally*, That the College shall also
23 accordingly upgrade or increase its human resource component as may be deemed appropriate by
24 the Board.
25

26 All parcels of land belonging to the government occupied by the ICNSF are hereby
27 declared property of the College and shall be titled under its name: *Provided*, That should the
28 College cease to exist or be abolished or should such aforementioned parcels of land be no
29 longer needed by the College, the same shall revert to the concerned LGU or to the Republic of
30 the Philippines, as the case may be.
31

32 **SEC. 18. Tax Exemption on Importation and Donations.** - The importation by the
33 College of economic, technical and cultural books or publications, which are for economic,
34 technical, vocational, scientific, philosophical, historical or cultural purposes shall, upon
35 certification by the CHED, be exempt from customs duties in accordance with the provisions of
36 Republic Act No. 10863, otherwise known as the “Customs Modernization and Tariff Act
37 (CMTA)”.
38

39 All grants, bequests, endowments, donations and contributions made to and used actually,
40 directly and exclusively by the College, shall be exempt from donor's tax and the same shall be
41 considered as allowable deduction from the gross income of the donor for purposes of computing
42 the taxable income of the donor, in accordance with the provisions of the National Internal
43 Revenue Code of 1997, as amended.
44

45 **SEC. 19. Compliance with CHED Requirements.** – The provisions of this Act
46 notwithstanding, the conversion of the ICNSF to a college shall become effective only upon the

1 determination and declaration by the CHED, based on the recommendation of a panel of experts
2 constituted for the purpose, that the institution has complied with the requirements for college
3 status under CHED Memorandum Order No. 46, series of 2012 (Policy-Standard to Enhance
4 Quality Assurance (QA) in Philippine Higher Education Through an Outcomes-Based and
5 Typology-Based QA); *Provided*, That the panel may issue such recommendation when the
6 institution has substantially complied with the requirements for the grant of college status.

7
8 The following operational requirements for a College, as established by the CHED, shall
9 be complied with:

- 10
11 a. Employment of full-time, permanent faculty members who possess relevant degrees,
12 as required by the CHED, and with experience in the subject areas they handle;
13
14 b. Offering of a comprehensive range of degree programs characterized by a core
15 curriculum that holistically develops thinking, problem solving, decision-making,
16 communication, technical, and social skills in line with the mission of the College;
17
18 c. Establishment and maintenance of comprehensive learning resources and support
19 structures that are appropriate for developing knowledge and skills in the specific
20 natural science, social science, humanities, and professional disciplines offered by the
21 College, including laboratories, books and journals;
22
23 d. Maintenance of linkage with the community that would ensure the development of
24 relevant academic and extension programs and the application of their learning
25 outcomes; and
26
27 e. Conduct of outreach programs involving students in social development-oriented
28 experiences that allow them to contextualize their knowledge within actual social and
29 human experiences.
30

31 The CHED, through its regional office, shall regularly provide technical assistance to the
32 College and monitor its compliance with the requirements of the Commission.

33
34 The ICNSF shall retain its status prior to the effectivity of this Act until it is able to
35 comply with the requirements provided herein.

36
37 **SEC. 20. *Development Plan, Management Audit, and***
38 ***Organizational/Administrative/Academic Structure.*** – Within a period of one hundred twenty
39 (120) days after the approval of this Act, the College shall accomplish the following:

- 40
41 a. Submit a five (5)-year development plan, including its program budget to the CHED
42 for recommendation to the DBM;
43
44 b. Set up its organizational, administrative, and academic structure, including the
45 appointment of key officials of the College; and
46

1 c. Undergo a management audit in coordination with the CHED.
2

3 **SEC. 21. *Filing of Report*** – On or before the fifteenth (15th) day of the second (2nd)
4 month after the opening of regular classes each year, the Board shall file with the Office of the
5 President of the Philippines, through the CHED Chairperson, and with both Houses of Congress,
6 a detailed report on the progress, condition, and needs of the College.
7

8 **SEC. 22. *Suppletory Application***. – The provisions of Republic Act No. 8292, otherwise
9 known as the “Higher Education Modernization Act of 1997”, shall form part of this Act and
10 serve as part of the governing charter of the College.
11

12 **SEC. 23. *Parity Clause***. – All other powers, functions, privileges, responsibilities, and
13 limitations under existing laws shall be deemed granted to or imposed upon the College and its
14 officials, whenever appropriate.
15

16 **SEC. 24. *Appropriations***. – The amount necessary to carry out the provisions of this Act
17 shall be included in the annual General Appropriations Act.
18

19 **SEC. 26. *Implementing Rules and Regulations***. – Within sixty (60) days from the
20 effectivity of this Act, the Board, in consultation with the CHED, shall formulate the rules and
21 regulations to fully implement the provisions of this Act.
22

23 **SEC. 27. *Separability Clause***. – If, for any reason, any part or provision of this Act is
24 declared invalid or unconstitutional, the remaining parts or provisions not affected shall remain
25 in full force and effect.
26

27 **SEC. 28. *Repealing Clause***. – All laws, presidential decrees, executive orders, and rules
28 and regulations contrary to or inconsistent with the provisions of this Act are repealed or
29 modified accordingly.
30

31 **SEC. 29. *Effectivity***. – This Act shall take effect fifteen (15) days after its publication in
32 the *Official Gazette* or in a newspaper of general circulation.
