





AN ACT
ESTABLISHING A PROVINCIAL OFFICE OF THE COMMISSION ON
HIGHER EDUCATION IN THE PROVINCE OF DAVAO ORIENTAL,
AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established a provincial office of the Commission on Higher
2 Education (CHED), to be known as the CHED-Davao Oriental Provincial Office, which
3 shall exercise jurisdiction over said province and shall be headed by a provincial director.
4 The CHED-Davao Oriental Provincial Office shall be located in the City of Mati, Province
5 of Davao Oriental.

7 SEC. 2. Within sixty (60) days from the approval of this Act, the CHED, in
8 coordination with the Department of Budget and Management (DBM), shall determine the
9 organizational structure and staffing pattern for the CHED-Davao Oriental Provincial
10 Office and submit the same to the Secretary of the Department of Budget and Management
11 for approval.

13 SEC. 3. The Chairperson of the CHED shall immediately include in the CHED's
14 program the operationalization of the CHED-Davao Oriental Provincial Office.
15

16 SEC. 4. The amount necessary to carry out the provisions of this Act shall be
17 included in the annual General Appropriations Act.

19 SEC. 5. The CHED shall issue the necessary rules and regulations for the effective
20 implementation of this Act within sixty (60) days from its approval.
21

22 SEC. 6. This Act shall take effect fifteen (15) days after its publication in the
23 *Official Gazette* or in a newspaper of general circulation.
