HOUSE BILL NO. 7695
(In substitution of House Bill No. 6120)

Introduced by Representatives Edgar M. Chatto, Mark O. Go, and Eric Go Yap

AN ACT
ESTABLISHING A PROVINCIAL OFFICE OF THE COMMISSION ON HIGHER
EDUCATION IN THE PROVINCE OF BOHOL, AND APPROPRIATING FUNDS
THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** There shall be established in Tagbilaran City, Province of Bohol, an office of
2 the Commission on Higher Education (CHED) to be known as the CHED-Bohol Provincial
3 Office. It shall be headed by a provincial director.
4

5 **SEC. 2.** Within sixty (60) days from the approval of this Act, the CHED shall
6 determine the organizational structure and staffing pattern for the CHED-Bohol Provincial
7 Office and submit the same to the Secretary of the Department of Budget and Management
8 for approval.
9

10 **SEC. 3.** The Chairperson of the CHED shall immediately include in the CHED's
11 program the operationalization of the CHED-Bohol Provincial Office.
12

13 **SEC. 4.** The amount necessary to carry out the provisions of this Act shall be
14 included in the annual General Appropriations Act.
15

16 **SEC. 5.** The CHED shall issue the necessary rules and regulations for the effective
17 implementation of this Act within sixty (60) days from its approval.
18

19 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication in the *Official*
20 *Gazette* or in a newspaper of general circulation.
