AN ACT
ESTABLISHING A PROVINCIAL OFFICE OF THE COMMISSION ON HIGHER
EDUCATION IN THE PROVINCE OF BATAAN, AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** There shall be established in the Province of Bataan, an office of the
2 Commission on Higher Education (CHED) to be known as the CHED-Bataan Provincial
3 Office. It shall be headed by a provincial director.
4

5 **SEC. 2.** The CHED shall determine the organizational structure and staffing pattern
6 for the CHED-Bataan Provincial Office and submit the same to the Department of Budget
7 and Management for approval.
8

9 **SEC. 3.** The Chairperson of the CHED shall immediately include in the CHED's
10 program the operationalization of the CHED-Bataan Provincial Office.
11

12 **SEC. 4.** The amount necessary to carry out the provisions of this Act shall be
13 included in the annual General Appropriations Act.
14

15 **SEC. 5.** Within sixty (60) days from the approval of this Act, the CHED shall issue
16 the necessary rules and regulations for its effective implementation.
17

18 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication in the *Official*
19 *Gazette* or in a newspaper of general circulation.
