HOUSE OF REPRESENTATIVES

BY REPRESENTATIVES RAMIREZ-SATO, GO (M.) AND YAP (E.), PER COMMITTEE REPORT NO. 958

AN ACT
ESTABLISHING A PROVINCIAL OFFICE OF THE COMMISSION ON HIGHER
EDUCATION IN THE MUNICIPALITY OF SAN JOSE, PROVINCE OF
OCCIDENTAL MINDORO, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 **SECTION 1.** There shall be established in the Municipality of San Jose, Province of
2 Occidental Mindoro, an office of the Commission on Higher Education (CHED), to be known
3 as the CHED-Occidental Mindoro Provincial Office. It shall be headed by a provincial director.
4
5 **SEC. 2.** The CHED shall determine the organizational structure and staffing pattern for
6 the CHED-Occidental Mindoro Provincial Office and submit the same to the Department of
7 Budget and Management for approval.
8
9 **SEC. 3.** The Chairperson of the CHED shall immediately include in the CHED's
10 program the operationalization of the CHED-Occidental Mindoro Provincial Office.
11
12 **SEC. 4.** The amount necessary to carry out the provisions of this Act shall be included
13 in the annual General Appropriations Act.

15 **SEC. 5.** Within sixty (60) days from the approval of this Act, the CHED shall issue the
16 necessary rules and regulations for its effective implementation.

18 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication in the *Official*
19 *Gazette* or in a newspaper of general circulation.
