AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) IN THE CITY OF BACOR, PROVINCE OF CAVITE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. There shall be established, under the supervision  
2 of the Land Transportation Franchising and Regulatory Board  
3 (LTFRB), a regular district office of the LTFRB in the City of  
4 Bacor, Province of Cavite.

5           SEC. 2. The Secretary of Transportation shall immediately  
6 include in the Department's program the operationalization of the  
7 LTFRB Regular District Office in the City of Bacor, Province of  
8 Cavite, the funding of which shall be included in the annual  
9 General Appropriations Act.

10          SEC. 3. This Act shall take effect fifteen (15) days after its  
11 publication in two (2) newspapers of general circulation.
