CONVERTING THE SATELLITE OFFICE OF THE MARITIME INDUSTRY
AUTHORITY LOCATED IN CALBAYOG CITY, PROVINCE OF SAMAR INTO AN
EXTENSION OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress
assembled:*

1 **SECTION 1.** The existing Maritime Industry Authority (MARINA) Satellite
2 Office in Calbayog City, Province of Samar is hereby converted into a regular
3 MARINA Extension Office. The extension office shall provide services for the
4 residents of the Provinces of Northern Samar, Samar, and Eastern Samar.

5 **SECTION 2.** The Administrator of MARINA shall immediately include in
6 the Agency's programs the operationalization of the MARINA Extension Office in
7 Calbayog City, Province of Samar, the funding of which shall be included in the
8 annual General Appropriations Act.

9 **SECTION 3. Effectivity.** — This Act shall become effective fifteen (15) days
10 after its publication in the *Official Gazette* or in a newspaper of general circulation.
