**AN ACT
CREATING AN EXTENSION OFFICE OF THE MARITIME INDUSTRY AUTHORITY
IN VIGAN CITY, ILOCOS SUR, AND APPROPRIATING FUNDS THEREFOR**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** An extension office of the Maritime Industry Authority
2 (MARINA) shall be created in Vigan City, Ilocos Sur. The extension office shall provide
3 services for the residents of the Province of Ilocos Sur and other nearby provinces.

4 **SECTION 2.** The Administrator of MARINA shall immediately include
5 in the Agency's programs the operationalization of the MARINA Extension Office in Vigan
6 City, Ilocos Sur, the funding of which shall be included in the annual General
7 Appropriations Act.

8 **SECTION 3.** This Act shall become effective fifteen (15) days after its
9 publication in the *Official Gazette* or in a newspaper of general circulation.

10 **Approved,**
