AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF  
THE LAND TRANSPORTATION OFFICE (LTO) IN THE  
MUNICIPALITY OF ALICIA, PROVINCE OF ISABELA

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There shall be established a regular district office  
2 of the Land Transportation Office (LTO) in the Municipality of  
3 Alicia, Province of Isabela.

4           SEC. 2. The Secretary of Transportation shall immediately  
5 include in the Department's program the operationalization  
6 of the LTO - Alicia District Office in the Province of Isabela,  
7 the funding of which shall be included in the annual General  
8 Appropriations Act.

9           SEC. 3. This Act shall take effect fifteen (15) days after its  
10 publication in two (2) newspapers of general circulation.
