AN ACT ESTABLISHING A DISTRICT OFFICE OF THE LAND
TRANSPORTATION OFFICE IN THE MUNICIPALITY
OF BALINGASAG, MISAMIS ORIENTAL, AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established a district office of the
2 Land Transportation Office (LTO) in the Municipality of
3 Balingasag, Misamis Oriental.

4 SEC. 2. The Secretary of the Department of Transportation
5 shall immediately include in the Department's program the
6 operationalization of the LTO District Office in the Municipality of
7 Balingasag, Misamis Oriental, the funding of which shall be
8 included in the annual General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.
