AN ACT ESTABLISHING A DISTRICT OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF LILOAN, PROVINCE OF CEBU AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be a district office of the Land
Transportation Office (LTO) to be located in the Municipality of
Liloan, Province of Cebu.

SEC. 2. The Secretary of the Department of Transportation (DOTr) shall immediately include in the Department's programs the operationalization of the LTO District Office in the Municipality of Liloan, Province of Cebu, the funding of which shall be included in the annual General Appropriations Act.

SEC. 3. The Secretary of the DOTr shall issue rules and regulations necessary for the effective implementation of this Act.

SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
