**AN ACT ESTABLISHING A DISTRICT OFFICE OF THE
LAND TRANSPORTATION OFFICE (LTO) IN THE
MUNICIPALITY OF LILOAN, PROVINCE OF CEBU AND
APPROPRIATING FUNDS THEREFOR**

*Be It enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** There shall be a district office of the Land
2 **Transportation Office (LTO)** to be located in the Municipality of
3 **Liloan, Province of Cebu.**

4 **SEC. 2.** The Secretary of the Department of Transportation
5 **(DOTr)** shall immediately include in the Department's programs the
6 **operationalization of the LTO District Office in the Municipality of**
7 **Liloan, Province of Cebu, the funding of which shall be included in**
8 **the annual General Appropriations Act.**

9 **SEC. 3.** The Secretary of the DOTr shall issue rules and
10 **regulations necessary for the effective implementation of this Act.**

11 **SEC. 4.** This Act shall take effect fifteen (15) days after its
12 **publication in the *Official Gazette* or in a newspaper of general**
13 **circulation.**
