- SECTION 1. There is hereby established a regular district

- 4 SEC. 2. The Secretary of the Department of Transportation
- 5 shall immediately include in the Department's program the
- 6 operationalization of the LTO district office in the Municipality of
- 7 Alcoy, Province of Cebu, the funding of which shall be included in
- 8 the annual General Appropriations Act.
- 9 SEC. 3. This Act shall take effect fifteen (15) days after its
- 10 publication in two (2) newspapers of general circulation.
