AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF THE
LAND TRANSPORTATION OFFICE (LTO) IN THE
MUNICIPALITY OF ALCOY, IN THE SECOND DISTRICT OF
CEBU AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established a regular district
2 office of the Land Transportation Office (LTO) to be located in the
3 Municipality of Alcoy in the Second District of Cebu.

4 SEC. 2. The Secretary of the Department of Transportation
5 shall immediately include in the Department's program the
6 operationalization of the LTO district office in the Municipality of
7 Alcoy, Province of Cebu, the funding of which shall be included in
8 the annual General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in two (2) newspapers of general circulation.
