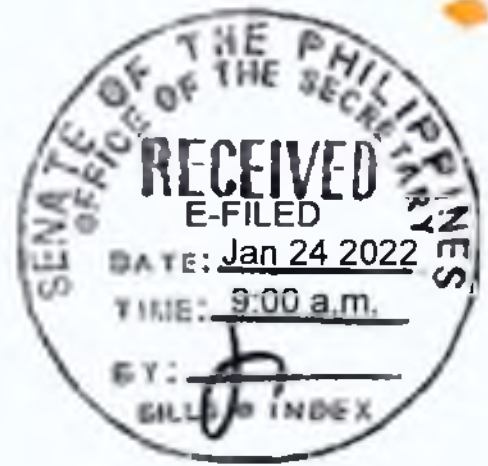

APPROPRIATING FUNDS THEREFOR**



AN ACT
ESTABLISHING A DISTRICT OFFICE OF THE LAND TRANSPORTATION
OFFICE IN THE MUNICIPALITY OF ENRIQUE B. MAGALONA IN THE
PROVINCE OF NEGROS OCCIDENTAL, AND APPROPRIATING FUNDS
THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There is hereby established a District Office of the Land Transportation
2 Office (LTO) to be located in the Municipality of Enrique B. Magalona in the Province of
3 Negros Occidental.

4
5 SEC. 2. The Secretary of the Department of Transportation shall immediately include
6 in the Department's program the operationalization of the LTO District Office in the
7 Municipality of Enrique B. Magalona in the Province of Negros Occidental, the funding of
8 which shall be included in the annual General Appropriations Act.

9
10 SEC. 3. This Act shall take effect fifteen (15) days after its publication in the *Official*
11 *Gazette* or in a newspaper of general circulation.
