AN ACT  
CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)  
EXTENSION OFFICE IN THE CITY OF PASSI, PROVINCE OF ILOILO,  
INTO A REGULAR LTO DISTRICT OFFICE AND APPROPRIATING  
FUNDS THEREFOR

*Be it enacted by the Senate and the House of Representatives of the  
Philippines in congress assembled:*

1           Section 1. The existing Passi Land Transportation Office (LTO) Extension  
2 Office in the City of Passi, Province of Iloilo, is hereby converted into a regular LTO  
3 district office.

4           Sec. 2. The Secretary of Transportation shall immediately include in the  
5 Department's programs the operationalization of the regular LTO district office in the  
6 City of Passi, Province of Iloilo, the initial funding of which shall be charged against  
7 the current year's appropriation of the Passi LTO Extension Office. Thereafter, such  
8 sum as may be necessary for the continued operation of the Passi LTO District Office  
9 shall be included in the annual General Appropriations Act.

10          Sec. 3. This Act shall take effect fifteen (15) days after its publication in the  
11 Official Gazette or in a newspaper of general circulation.

*Approved,*
