AN ACT  
ESTABLISHING A REGULAR DISTRICT OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF GUIPOS,  
PROVINCE OF ZAMBOANGA DEL SUR, AND APPROPRIATING FUNDS  
THEREFOR

*Be it enacted by the Senate and the House of Representatives of the Philippines  
in Congress assembled:*

1           Section 1. There shall be established a regular district office of the Land  
2 Transportation Office (LTO) in the Municipality of Guipos, Province of Zamboanga  
3 del Sur, to be known as the "LTO District Office of Guipos".

4           Sec. 2. The Secretary of the Department of Transportation (DOTr) shall  
5 immediately include in the Department's program the operationalization of the LTO  
6 District Office in the Municipality of Guipos, Province of Zamboanga del Sur, the  
7 funding of which shall be included in the annual General Appropriations Act.

8           Sec. 3. The Secretary of DOTr shall issue such rules and regulations as may be  
9 necessary to carry out the provisions of this Act.

10          Sec. 4. This Act shall take effect fifteen (15) days after its publication in the  
11 *Official Gazette* or in a newspaper of general circulation.
