AN ACT
ESTABLISHING A REGULAR DISTRICT OFFICE OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF
PAGSANJAN, PROVINCE OF LAGUNA AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and the House of Representatives of the
Philippines in Congress assembled:*

1 Section 1. There shall be established a regular district office of the Land
2 Transportation Office (LTO) in the Municipality of Pagsanjan, Province of Laguna
3 which shall serve the Fourth Congressional District of Laguna and the neighboring
4 provinces and towns.

5 Sec. 2. The Secretary of Transportation shall immediately include in the
6 Department's programs the operationalization of the regular LTO district office in the
7 Municipality of Pagsanjan, Province of Laguna, the funding of which shall be
8 included in the annual General Appropriations Act.

9 Sec. 3. This Act shall take effect fifteen (15) days after its publication in the
10 *Official Gazette* or in a newspaper of general circulation.
