The Committee on Public Services, joint with the Committee on Finance, to which were referred **House Bill No. 861**, introduced by **Representatives Hernandez, Sarmiento and Ungab**, entitled:

AN ACT

CREATING A REGULAR LTO DISTRICT OFFICE IN THE MUNICIPALITY OF POLOMOLOK, SOUTH COTABATO TO BE KNOWN AS THE LTO LICENSING CENTER OF POLOMOLOK, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

and **Senate Bill No. 1313**, introduced by **Senator Binay**, entitled:

AN ACT

CREATING A REGULAR LTO DISTRICT OFFICE IN THE MUNICIPALITY OF POLOMOLOK, SOUTH COTABATO, TO BE KNOWN AS THE 'LTO LICENSING CENTER OF POLOMOLOK', AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

have considered the same and have the honor to report back to the Senate with the recommendation that **House Bill No. 861**, taking into consideration **Senate Bill No. 1313**, be approved with the following amendments:

1. On page 1, line 1, delete the phrase "A Regular District" and replace it with the phrase "**THE LAND TRANSPORTATION OFFICE (LTO) EXTENSION**";
2. On the same page, line 2, delete the word "created" and replace it with the phrase "**CONVERTED INTO A "CLASS B" DISTRICT OFFICE**";
3. On the same page, lines 3 and 10, delete the phrase "Licensing Center" and replace it with the phrase "**DISTRICT OFFICE**";
4. On the Title, first line, delete the phrase "CREATING A REGULAR LTO DISTRICT" and replace it with the phrase "**CONVERTING THE LTO EXTENSION**"; on the second line, between the words "COTABATO" and "TO", insert the phrase "**INTO A "CLASS B" DISTRICT OFFICE**"; and on the third line, delete the phrase "LICENSING CENTER" and replace it with the phrase "**DISTRICT OFFICE**".

AN ACT CREATING A REGULAR LTO DISTRICT OFFICE IN THE MUNICIPALITY OF POLOMOLOK, SOUTH COTABATO TO BE KNOWN AS THE LTO LICENSING CENTER OF POLOMOLOK, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. A Regular District Office in the Municipality of
2 Polomolok, South Cotabato is hereby created to be known as the
3 LTO Licensing Center of Polomolok.

4 SEC. 2. The Secretary of Transportation shall immediately
5 include in the Department's programs the operationalization of a
6 Regular LTO District Office in the Municipality of Polomolok, the
7 initial funding of which shall be charged against the current year's
8 appropriation of the existing LTO Polomolok Extension Office.
9 Thereafter, such sums as may be necessary for the continued
10 operation of the LTO Licensing Center of Polomolok shall be
11 included in the annual General Appropriations Act.

12 SEC. 3. The Secretary of Transportation shall issue such
13 rules and regulations necessary for the effective implementation of
14 this Act.

1 SEC. 4. This Act shall take effect after fifteen (15) days
2 following the completion of its publication in the *Official Gazette* or
3 in two (2) newspapers of general circulation.
