**Mr. President:**

The Committee on Public Services, joint with the Committee on Finance, to which was referred **House Bill No. 2106**, introduced by **Representatives Aumentado, Sarmiento and Ungab**, entitled:

**AN ACT**  
**CONVERTING THE SATELLITE OFFICE OF THE LAND**  
**TRANSPORTATION OFFICE (LTO) IN THE SECOND DISTRICT OF THE**  
**PROVINCE OF BOHOL INTO A REGULAR LTO DISTRICT OFFICE AND**  
**APPROPRIATING FUNDS THEREFOR**

3. On the Title, first line, delete the word "SATELLITE" and replace it with the word "**EXTENSION**"; and on the third line, delete the word "REGULAR" and replace it with the phrase "**CLASS C**".

AN ACT CONVERTING THE SATELLITE OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE SECOND DISTRICT  
OF THE PROVINCE OF BOHOL INTO A REGULAR LTO  
DISTRICT OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1           SECTION 1. The existing Land Transportation Office (LTO)  
2     Satellite Office in the Second District of the Province of Bohol is  
3     hereby converted into a regular LTO District Office.

4           SEC. 2. The Secretary of Transportation shall include in the  
5     Department's program the operationalization of a regular LTO  
6     District Office in the Second District of the Province of Bohol, the  
7     initial funding of which shall be charged against the current year's  
8     appropriation of the Satellite Office located in the Municipality of  
9     Talibon, Province of Bohol. Thereafter, such sums as may be  
10    necessary for the continued operation of the regular LTO District  
11    Office shall be included in the annual General Appropriations Act.

12          SEC. 3. This Act shall take effect fifteen (15) days after its  
13    complete publication in at least two (2) newspapers of general  
14    circulation.
