The Committee on Public Services, joint with the Committee on Finance, to which was referred **House Bill No. 3286**, introduced by **Representatives Ferrer (J.), Sarmiento and Ungab**, entitled:

AN ACT
ESTABLISHING A DISTRICT BRANCH OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE CITY OF LA CARLOTA IN
THE FOURTH DISTRICT OF THE PROVINCE OF NEGROS OCCIDENTAL,

AN ACT ESTABLISHING A DISTRICT BRANCH OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE CITY OF
LA CARLOTA IN THE FOURTH DISTRICT OF THE
PROVINCE OF NEGROS OCCIDENTAL, APPROPRIATING
FUNDS THEREFOR AND FOR OTHER PURPOSES

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. *Establishment of an LTO Branch in La Carlota*
2 City. – There shall be established a district branch of the
3 Land Transportation Office (LTO) to be located in the City of
4 La Carlota, serving the City of La Carlota, Fourth District of the
5 Province of Negros Occidental including the municipalities of
6 Pontevedra, Pulpandan, San Roque, Valladolid and other nearby
7 municipalities.

8 SEC. 2. *Appropriation.* – The Secretary of the Department of
9 Transportation shall immediately include in the Department's
10 program the operationalization of the LTO District Branch in the
11 City of La Carlota, Fourth District of the Province of Negros
12 Occidental, the funding of which shall be included in the annual
13 General Appropriations Act.

1 **SEC. 3. *Implementing Rules and Regulations.*** – The
2 **Secretary of Transportation shall issue such rules and regulations**
3 **as may be necessary to carry out the purpose of this Act.**

4 **SEC. 4. *Effectivity.*** – This Act shall take effect fifteen (15)
5 **days after its publication in the *Official Gazette.***
