The Committee on Public Services, joint with the Committee on Finance, to which was referred **House Bill No. 4597**, introduced by **Representatives Baronda, Sarmiento** and **Ungab**, entitled:

**AN ACT**

AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE REGION VI OF ILOILO CITY INTO A REGULAR LICENSING CENTER TO BE KNOWN AS THE ILOILO CITY LICENSING CENTER, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. *Conversion into a Regular Licensing Center.* –  
2 The Land Transportation Office (LTO) Licensing Center in Iloilo  
3 City is hereby converted into a Regular Licensing Center to be  
4 known as the Iloilo City Licensing Center.

5           SEC. 2. *Appropriations.* – The Secretary of Transportation  
6 shall immediately include in the Department's programs the  
7 operationalization of the Iloilo City Licensing Center, the initial  
8 funding of which shall be charged against the current year's  
9 appropriation of the LTO Region VI of Iloilo City. Thereafter, such  
10 sums as may be necessary for the continued implementation of this  
11 Act shall be included in the annual General Appropriations Act.

12           SEC. 3. *Effectivity.* – This Act shall take effect fifteen (15)  
13 days after its publication in the *Official Gazette* or in a newspaper of  
14 general circulation.
