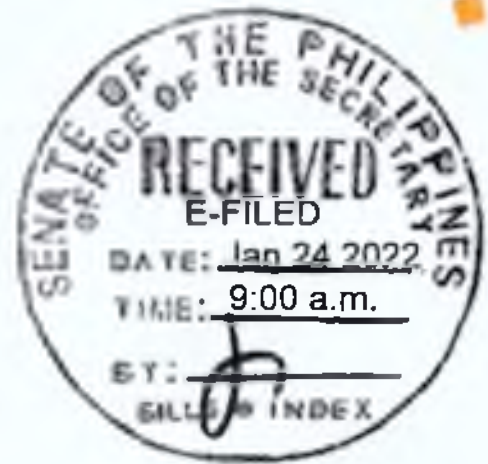

**Mr. President:**

The Committee on Public Services, joint with the Committee on Finance, to which was referred **House Bill No. 5153**, introduced by **Representatives Cari, Sarmiento** and **Ungab**, entitled:

**AN ACT  
ESTABLISHING A REGULAR DISTRICT OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF JAVIER,  
PROVINCE OF LEYTE, AND APPROPRIATING FUNDS THEREFOR**

have considered the same and have the honor to report back to the Senate with the recommendation that it be approved with the following amendments:

1. On line 1, delete the phrase "A regular district" and replace it with the phrase "**THE EXTENSION**";
2. On line 2, delete the phrase "is hereby established";
3. On line 3, after the word "Leyte", insert the phrase ", **IS HEREBY CONVERTED INTO A REGULAR DISTRICT OFFICE TO BE KNOWN AS THE LTO JAVIER DISTRICT OFFICE**";
4. On line 7, between the words "the" and "funding", insert the word "INITIAL"; and between the words "which" and "shall", insert the phrase:

**"SHALL BE CHARGED AGAINST THE CURRENT YEAR'S APPROPRIATION OF THE LTO JAVIER EXTENSION OFFICE. THEREAFTER, SUCH SUMS AS MAY BE NECESSARY FOR THE CONTINUED OPERATION OF THE REGULAR LTO DISTRICT OFFICE"; and**

5. On the Title, first line, delete the phrase "ESTABLISHING A REGULAR DISTRICT" and replace it with the phrase "**CONVERTING THE EXTENSION**"; and on the third line, between the words "LEYTE," and the word "AND"; insert the phrase "**INTO A REGULAR DISTRICT OFFICE,**".







AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF THE  
LAND TRANSPORTATION OFFICE (LTO) IN THE  
MUNICIPALITY OF JAVIER, PROVINCE OF LEYTE, AND  
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1           SECTION 1. A regular district office of the Land Transportation  
2   Office (LTO) is hereby established in the Municipality of Javier,  
3   Province of Leyte.

4           SEC. 2. The Secretary of Transportation shall immediately  
5   include in the Department's program the operationalization of the  
6   regular LTO District Office in the Municipality of Javier, Province of  
7   Leyte, the funding of which shall be included in the annual General  
8   Appropriations Act.

9           SEC. 3. This Act shall take effect fifteen (15) days after its  
10   publication in the *Official Gazette* or in a newspaper of general  
11   circulation.
