**AN ACT  
ESTABLISHING A DISTRICT BRANCH OF THE LAND TRANSPORTATION  
OFFICE (LTO) IN THE MUNICIPALITY OF CATAINGAN IN THE 3<sup>rd</sup> DISTRICT  
OF MASBATE, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

- 1 Section 1. There is hereby established a district branch of the Land Transportation Office  
2 (LTO) to be located in the Municipality of Cataingan which shall serve the 3<sup>rd</sup> District of  
3 Masbate and its neighboring towns.
- 4 Sec. 2. The Secretary of the Department of Transportation shall immediately include in  
5 the DOTr's programs the operationalization of the LTO District Office in the  
6 Municipality of Cataingan, Province of Masbate, the funding of which shall be included  
7 in the annual General Appropriations Act.
- 8 Sec. 3. The Secretary of Transportation shall formulate the necessary rules and  
9 regulations to carry out the purpose of this Act.
- 10 Sec. 4. This Act shall take effect fifteen (15) days after its publication in the *Official*  
11 *Gazette* or in a newspaper of general circulation.
