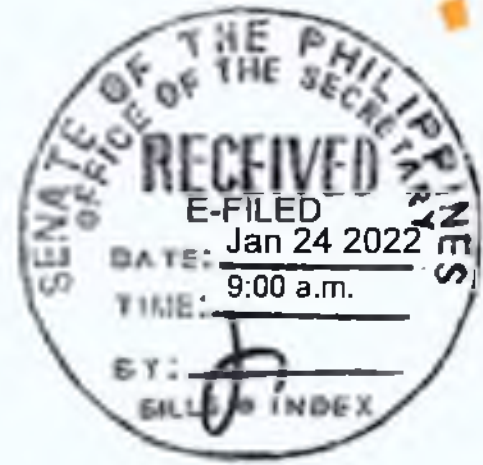

The Committee on Public Services, joint with the Committee on Finance, to which was referred **House Bill No. 6152**, introduced by **Representatives Umali (A.), Sarmiento and Yap (E.)**, entitled:

AN ACT
ESTABLISHING A SATELLITE OFFICE OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF
PINAMALAYAN, ORIENTAL MINDORO AND APPROPRIATING FUNDS
THEREFOR

have considered the same and have the honor to report back to the Senate with the recommendation that it be approved with the following amendments:


1. On line 1, delete the phrase "There shall be established a satellite" and replace it with the word "**THE EXTENSION**";
2. On line 3, between the words "Mindoro" and "to", insert the phrase "**IS HEREBY CONVERTED INTO A "CLASS B" DISTRICT OFFICE**";
3. On line 4, after the word "Transportation", insert the word "**OFFICE**" and the acronym "**(LTO)**"
4. On line 8, delete the word "Satellite" and replace it with the word "**DISTRICT**"; and

5. On the Title, second line, delete the phrase "ESTABLISHING A SATELLITE" and replace it with the phrase "**CONVERTING THE EXTENSION**"; and on fourth line, after the word "MINDORO", insert the phrase "**INTO A DISTRICT OFFICE TO BE KNOWN AS THE LTO DISTRICT OFFICE – PINAMALAYAN**"

**AN ACT
ESTABLISHING A SATELLITE OFFICE OF THE
LAND TRANSPORTATION OFFICE (LTO) IN THE
MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO
AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of
the Philippines in Congress assembled:*

- 1 **Section 1.** There shall be established a satellite office of the Land
2 Transportation Office (LTO) in the Municipality of Pinamalayan,
3 Province of Oriental Mindoro to be known as the Land
4 Transportation District Office - Pinamalayan.
5
6 **Section 2.** The Secretary of Transportation shall immediately
7 include in the Department's program the operationalization of the
8 LTO Satellite Office in the Municipality of Pinamalayan, Oriental
9 Mindoro, the funding of which shall be included in the annual
10 General Appropriations Act.
11
12 **Section 3.** This Act shall take effect fifteen (15) days after its
13 publication in the *Official Gazette* or in at least two (2) newspapers
14 of general circulation.
