Mr. President:

The Committee on Public Services, joint with the Committee on Finance to which was referred **House Bill No. 8654**, introduced by **Representatives Violago, Sarmiento and Yap (E.)**, entitled:

AN ACT
CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
EXTENSION OFFICE IN SAN JOSE CITY, PROVINCE OF NUEVA ECJA
INTO A REGULAR LTO DISTRICT OFFICE, AND APPROPRIATING
FUNDS THEREFOR

have considered the same and have the honor to report back to the Senate with the recommendation that it be approved with the following amendments:

1. On lines 1 and 8, delete the word "Extension" and replace it with the word "**DISTRICT**";
2. On line 2, delete the words "converted" and "regular" and replace them with the words "**UPGRADED**" and "**CLASS B**", respectively;
3. On lines 2 and 3, delete the phrase "to be known as the LTO District Office of San Jose City, Nueva Ecija";
4. On line 5, delete the word "operationalization" and replace it with the word "**UPGRADING**", and delete the word "regular";

5. On line 9, delete the word "regular" and replace it with the word "**UPGRADED**"; and
6. On the Title, second line, delete the word "CONVERTING" and replace it with the word "**UPGRADING**"; on the third line, delete the word "EXTENSION" and replace it with the word "**DISTRICT**"; and on the fourth line, delete the word "REGULAR" and replace it with the phrase "**CLASS B**".

AN ACT
CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
EXTENSION OFFICE IN SAN JOSE CITY, PROVINCE OF NUEVA ECIJA
INTO A REGULAR LTO DISTRICT OFFICE, AND APPROPRIATING
FUNDS THEREFOR

*Be it enacted by the Senate and the House of Representatives of the Philippines
in Congress assembled:*

1 **SECTION 1.** The Land Transportation Office (LTO) Extension Office in San
2 Jose City, Province of Nueva Ecija is hereby converted into a regular district office to
3 be known as the LTO District Office of San Jose City, Nueva Ecija.

4 **SEC. 2.** The Secretary of Transportation shall immediately include in the
5 Department's programs the operationalization of the regular LTO district office in San
6 Jose City, Province of Nueva Ecija, the initial funding of which shall be charged against
7 the current year's appropriations of the existing Land Transportation Office (LTO)
8 Extension Office in San Jose City. Thereafter, such sum as may be necessary for the
9 continued operation of the regular San Jose City LTO district office shall be included
10 in the annual General Appropriations Act.

11 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the
12 *Official Gazette* or in a newspaper of general circulation.
