**"AN ACT**

**DIVIDING BARANGAY PASONG PUTIK IN QUEZON CITY INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY PASONG PUTIK PROPER, BARANGAY GREATER LAGRO AND BARANGAY NORTH FAIRVIEW"**

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 9971 be approved with the following amendments:


1. On page 2, lines 19 to 22, delete entire Section 6, and replace with a new Section 6, to read thus:

**"SEC. 6. NATIONAL TAX ALLOTMENT SHARES. – BARANGAYS PASONG PUTIK PROPER, GREATER LAGRO, AND NORTH FAIRVIEW SHALL BE ENTITLED TO AN ALLOTMENT DERIVED FROM NATIONAL TAXES PURSUANT TO SECTION 285 OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE, AS AMENDED."**

2. Finally, to renumber the Sections accordingly, and subject to style.







AN ACT

DIVIDING BARANGAY PASONG PUTIK IN QUEZON CITY INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY PASONG PUTIK PROPER, BARANGAY GREATER LAGRO AND BARANGAY NORTH FAIRVIEW

*Be it enacted by the Senate and the House of Representatives  
of the Philippines in Congress assembled:*

1           **SECTION 1. *Division of Barangay Pasong Putik.*** – Barangay Pasong Putik in Quezon City  
2 is hereby divided into three (3) distinct and independent barangays to be known as Barangay  
3 Pasong Putik Proper, Barangay Greater Lagro and Barangay North Fairview.

4           **SEC. 2. *Territorial Boundaries.*** – The territorial boundaries of each barangay created in  
5 the preceding section are hereby described as follows:

6           **(1) Barangay Pasong Putik Proper**

7                   “Bounded on the North by Caloocan City and Quezon City Boundary;  
8                   On the East by Belfast Street, Caloocan City and Quezon City Boundary;  
9                   On the West by Kaligayhan/New Haven and Teresa Heights Boundary;  
10                   On the South by Quirino Highway, Mindanao Avenue;”

11           **(2) Barangay Greater Lagro**

12                   “Bounded on the North by Quirino Highway;  
13                   On the East by the MWSS Reservoir;  
14                   On the West by Belfast Street, Mindamao Avenue, Barangay Sta. Monica and  
15                   Barangay Pasong Putik Boundary;  
16                   On the South by a creek, D.B.T. Marbay/Lagro Subdivision Boundary.

1           **(3) Barangay North Fairview**

2                   “Bounded on the North by a creek, D.B.T. Marbay/Lagro Subdivision Boundary;  
3                   On the East by Lagro Subdivision, Tullahan Creek;  
4                   On the West by Barangay Sta. Monica and North Fairview Subdivision Boundary;  
5                   On the South by Barangay Fairview and Tullahan Creek.”

6           **SEC. 3. Conduct and Supervision of Plebiscite.** – The plebiscite conducted and supervised  
7 by the Commission on Elections (COMELEC) pursuant to Quezon City Ordinance No. 439, Series  
8 of 1996 of the Sangguniang Panlungsod of Quezon City, which ratified the creation of Barangays  
9 Pasong Putik Proper, Barangay Greater Lagro and Barangay North Fairview as proclaimed by the  
10 Plebiscite Board of Canvassers on December 8, 1996 shall serve as substantial compliance with  
11 the plebiscite requirement under Section 10 of Republic Act No. 7160, otherwise known as the  
12 Local Government Code of 1991, as amended.

13           **SEC. 4. Incumbent Barangay Officials.** – The incumbent barangay officials of Barangays  
14 Pasong Putik Proper, Greater Lagro and North Fairview shall continue to hold office until such  
15 time that their successors have been duly elected and qualified.

16           **SEC. 5. Public Infrastructure and Facilities.** – All public infrastructure and facilities for  
17 public use existing therein at the time of the approval of this Act shall continue to be owned and  
18 administered by barangays herein created under Section 1 of this Act.

19           **SEC. 6. Internal Revenue Allotment (IRA) Shares.** – Barangays Pasong Putik Proper,  
20 Greater Lagro and North Fairview shall be entitled to Internal Revenue Allotment (IRA) shares  
21 pursuant to Section 285 of Republic Act No. 7160 otherwise known as the Local Government  
22 Code of 1991, as amended.

23           **SEC. 7. Repealing Clause.** – All laws, decrees, executive orders, rules and regulations  
24 contrary to or inconsistent with any provision of this Act are hereby repealed or amended  
25 accordingly.

26           **SEC. 8. Effectivity.** – This Act shall take effect fifteen (15) days after its publication in the  
27 *Official Gazette* or in a newspaper of general application.

**Approved,**
