AN ACT

ESTABLISHING IN THE MUNICIPALITY OF BOCAUE, PROVINCE OF BULACAN, A GENERAL HOSPITAL TO BE KNOWN AS THE JONI VILLANUEVA GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be established in the Municipality of Bocaue, Province of Bulacan, a level 2 general hospital to be known as the Joni Villanueva General Hospital, which shall be under the direct control and supervision of the Department of Health (DOH).

SEC. 2. Any future increase in bed capacity, healthcare facilities, service capability, and human resource complement shall be based on the hospital development plan which shall be prepared by the DOH.

SEC. 3. The Secretary of the DOH shall immediately include in the Department's program the implementation of this Act, the funding of which shall be included in the annual General Appropriations Act.

13 SEC. 4. If any provision or part of this Act is declared unconstitutional, the remaining 14 parts or provisions not affected shall remain in full force and effect.

16 SEC. 5. All laws, executive orders, issuances, rules and regulations, inconsistent 17 with this Act are hereby repealed or modified accordingly.

SEC. 6. This Act shall take effect fifteen (15) days after its publication in the Official
Gazette or in a newspaper of general circulation.
