

has considered the same and has the honor to report it back to the Senate with the recommendation that House Bill No. 8842, be approved without amendment.





RENAMING THE CAGAYAN DE ORO CONVENTION CENTER LOCATED AT BARANGAY INDAHAG, CAGAYAN DE ORO CITY AS AQUILINO Q. PIMENTEL, JR. INTERNATIONAL CONVENTION CENTER

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Cagayan de Oro Convention Center located at Barangay
2 Indahag, Cagayan de Oro City is hereby renamed as Aquilino Q. Pimentel, Jr.
3 International Convention Center.

4 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the
5 Official Gazette or in a newspaper of general circulation.
