# AN ACT

EXEMPTING FROM INCOME TAXATION THE HONORARIA, ALLOWANCES, AND OTHER FINANCIAL BENEFITS OF PERSONS RENDERING SERVICE DURING AN ELECTION PERIOD, AMENDING FOR THE PURPOSE SECTION 32 (B) (7) OF THE NATIONAL INTERNAL REVENUE CODE OF 1997, AS AMENDED

Be it enacted by the Senate and House of Representatives by the Congress assembled:

- 1 SECTION 1. Section 32 (B) (7) of the National Internal Revenue Code of 1997, as
- 2 amended, is hereby further amended to read as follows:

14 OF REPUBLIC ACT NO. 10756, OTHERWISE2KNOWN AS THE "ELECTION SERVICE3REFORM ACT": PROVIDED, THAT THIS SHALL4APPLY TO THE MAY 9, 2022 NATIONAL AND5LOCAL ELECTIONS AND THEREAFTER."

SEC. 2. *Implementing Rules and Regulations.* - The Department of Finance shall,
in consultation with the Commission on Elections and the Department of Education,
promulgate rules and regulations to implement the provisions of this Act within sixty
(60) days from its effectivity.

SEC. 3. Separability Clause. - If any portion or provision of this Act is declared void
and unconstitutional, the remaining portions or provisions hereof shall not be
affected by such declaration.

SEC. 4. *Repealing Clause.* - All laws, decrees, rules and regulations, and other
 issuances inconsistent with this Act are hereby repealed or modified accordingly.

SEC. 5. *Effectivity Clause.* - This Act shall take effect after fifteen (15) days
following its complete publication either in the Official Gazette or in a newspaper of
general circulation.
