At 3:52 p.m., the Senate President, Hon. Franklin M. Drilon, called the session to order.

COMMITTEE REPORT NO. 7 ON SENATE BILL NO. 1862

(Continuation)

Upon motion of Senator Pangilinan, there being no objection, the Body resumed consideration, on Second Reading, of Senate Bill No. 1862 (Committee Report No. 7), entitled

AN ACT PRESCRIBING A FIXED TERM OF OFFICE FOR THE CHIEF OF STAFF AND THE MAJOR SERVICE COMMANDERS OF THE ARMED FORCES OF THE PHILIPPINES (AFP) AND FOR OTHER PURPOSES.

Senator Pangilinan stated that the parliamentary status was the period of individual amendments.

Thereupon, the Chair recognized Senator Biazon, Sponsor of the measure.

RECONSIDERATION OF THE TERMINATION OF THE PERIOD OF COMMITTEE AMENDMENTS

Upon motion of Senator Pangilinan, there being no objection, the Body reconsidered the termination of the period of committee amendments.

PROPOSED COMMITTEE AMENDMENT

On page 1, after line 9, Senator Biazon proposed to insert a new paragraph to read as follows:

WHEN THE OFFICERS SO APPOINTED UNDER THIS SECTION REACH THE COMPULSORY RETIREMENT AGE BEFORE THE END OF THEIR TERMS, THEY SHALL BE ALLOWED TO COMPLETE THEIR TERMS BUT SHALL BE DEEMED COMPULSORILY RETIRED UPON COMPLETION OF THE SAME.

To the observation of the Chair that the safne provision is found on lines 21 and 22 of page 1 and line 1 of page 2, Senator Biazon stated that said lines would be deleted.

Senator Enrile cautioned that the Body might be enacting a law that would violate Article XVI, Section 5 (5) of the Constitution which provides that, "Laws on retirement of military officers shall not allow extension of their service." He reasoned that the proposed amendment would, in effect, sanction the extension of the tenure of a retirable officer who is occupying the position.
