MANIFESTATION OF SENATE PRESIDENT ZUBIRI

Senate President Zubiri informed the Members that the President had ordered the suspension of work in all government offices and of classes in all levels in public schools in the National Capital Region and nearby provinces that day until August 24 due to the effects of severe Tropical Storm *Florita*.

Since the suspension had been announced around noontime when most of the Members were already attending committee hearings, he explained that the Body was actually working overtime by holding the plenary session that afternoon.

As for the committee meetings which are scheduled on the days covered by the work suspension, he said that he would let the committee chairpersons decide whether they want to continue holding their hearings while

working from home, or to reschedule the same on Tuesday of the following week since Monday, August 29, 2022 is a national holiday.
