AN ACT
CREATING A BARANGAY IN THE CITY OF TAGUIG
TO BE KNOWN AS BARANGAY TANYAG

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1. *Creation of Barangay Tanyag.*** – Tanyag Proper in Barangay Bagong
2 Tanyag, City of Taguig is hereby separated from Barangay Bagong Tanyag and constituted into a
3 distinct and independent barangay to be known as Barangay Tanyag.

4 **SEC. 2. *Territorial Boundaries.*** – The territorial boundaries of Barangay Tanyag are
5 hereby described as follows:

6 “Bounded on the North by Mañalac Avenue;

7 On the East by Manila Railroad Company (Railroad Tract);

8 On the South by Lots 8019, 8018, 8025 Case 15 Mcadm 590-D Taguig Cadastral Mapping;

9 and

10 On the West by North Daang Hari Road and Parañaque Cadastre.”

11 **SEC. 3. *Conduct and Supervision of Plebiscite.*** – The plebiscite conducted and supervised
12 by the Commission on Elections in Barangay Bagong Tanyag pursuant to City Ordinance No. 25,
13 Series of 2008 of the Sangguniang Panlungsod of the City of Taguig, which ratified the creation
14 of Barangay Tanyag as proclaimed by the City Board of Canvassers on December 28, 2008, shall
15 serve as substantial compliance with the plebiscite requirement under Section 10 of Republic Act
16 No. 7160 as amended, otherwise known as the Local Government Code of 1991.

1 **SEC. 4. *Incumbent Barangay Officials.*** – The incumbent barangay officials of Barangay
2 Tanyag, City of Taguig shall continue to hold office until such time that their successors have been
3 duly elected and qualified.

4 **SEC. 5. *Public Infrastructure and Facilities.*** – All public infrastructure and facilities
5 existing therein at the time of the approval of this Act are hereby transferred without cost or
6 compensation to and shall be administered by the new barangay.

7 **SEC. 6. *National Tax Allotment Shares.*** – Barangay Tanyag shall be entitled to the
8 National Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991,
9 as amended.

10 **SEC. 7. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in
11 the *Official Gazette* or in a newspaper of general circulation.
