AN ACT  
CREATING A BARANGAY IN THE MUNICIPALITY OF BAROBO, PROVINCE OF SURIGAO  
DEL SUR, TO BE KNOWN AS BARANGAY GUINHALINAN

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1. *Creation of Barangay Guinhalinan.*** – There is hereby created a barangay in  
2           the Municipality of Barobo, Province of Surigao del Sur, to be known as Barangay Guinhalinan.

3           [ **SEC. 2. *Territorial Boundaries.*** ~~The territorial boundaries of Barangay Guinhalinan shall~~  
4           ~~be described as follows:~~

5 ~~[SEC. 3. *Conduct and Supervision of Plebiscite.*—The plebiscite conducted and supervised~~  
6 ~~by the Commission on Elections pursuant to *Sangguniang Panlalawigan ng Surigao* Provincial~~  
7 ~~Resolution No. 79-16, which was duly ratified and proclaimed by the Plebiscite Board of Canvassers~~  
8 ~~on August 1, 1979, shall serve as substantial compliance with the plebiscite requirement under~~  
9 ~~Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code~~  
10 ~~of 1991.]~~

11 SEC. 3. *CONDUCT AND SUPERVISION OF PLEBISCITE.* – THE COMMISSION  
12 ON ELECTIONS (COMELEC) SHALL CONDUCT AND SUPERVISE THE  
13 PLEBISCITE TO BE HELD IN BARANGAY GUINHALINAN, BAROBO, SURIGAO  
14 DEL SUR, WITHIN NINETY (90) DAYS FROM THE EFFECTIVITY OF THIS ACT. THE  
15 MUNICIPALITY OF BAROBO SHALL SHOULDER THE EXPENSES FOR SUCH  
16 PLEBISCITE.

18 ~~[SEC. 4. *Incumbent Barangay Officials.*—The incumbent elected barangay officials of~~  
19 ~~Barangay Guinhalinan shall continue to hold office until such time that their successors have been~~  
20 ~~duly elected and qualified.]~~

21 SEC. 4. *APPOINTMENT OF INTERIM BARANGAY OFFICIALS.* – THERE SHALL  
22 BE A PUNONG BARANGAY, SEVEN (7) SANGGUNIANG BARANGAY MEMBERS,  
23 A SANGGUNIANG KABATAAN CHAIRMAN, AND SEVEN (7) SANGGUNANG  
24 KABATAAN MEMBERS IN THE NEWLY CREATED BARANGAY WHICH SHALL BE  
25 APPOINTED BY THE MAYOR. SUCH BARANGAY OFFICIALS SHALL SERVE  
26 UNTIL THEIR SUCCESSORS SHALL HAVE BEEN DULY ELECTED AND  
27 QUALIFIED.  
28

29 SEC. 5. *Public Infrastructures and Facilities.* – All public infrastructures and facilities  
30 existing therein at the time of the approval of this Act are hereby transferred without cost or  
31 compensation to and shall be administered by the new barangay.

1                   **SEC. 6. *National Tax Allotment Shares.*** – Barangay Guinhalinan shall be entitled to  
2 National Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991, as  
3 amended.

5                   **SEC. 7. *Repealing Clause.*** - All laws, decrees, executive orders, rules, and regulations  
6 which are inconsistent with this Act are hereby repealed or modified accordingly.  
7

8                   **SEC. 8. *Effectivity.*** - This Act shall take effect fifteen (15) days after its publication in the  
9 *Official Gazette* or in a newspaper of general circulation.
